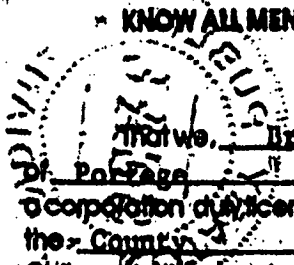

 as Electrical Contractor by the said Obligees,

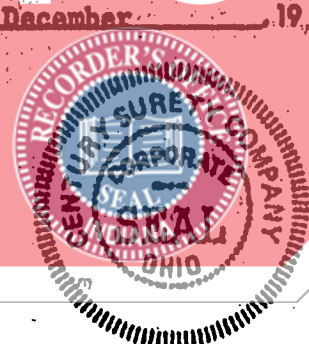


