DEED IN TRUST

THIS INDENTURE WITNESSETH, that the Grantor, NAOMI L. BOI-LEK, of Lake County, Indiana, for and in consideration of the sum of Ten (\$10.00) Dollars, and other good and valuable consideration, the receipt of which is hereby acknowledged, conveys and warrants to NAOMI L. BOILEK, as Trustee, under the provisions of that certain Trust Agreement dated the 12th day of December, 1990, and known as the Boilek Living Trust, the following described real estate in Lake County, Indiana, to wit:

force and effect, (b) that such conveyance or other instrument was executed in accordance with the trusts, conditions and limitations contained in this Indenture and in the Trust Agreement or in all amendments thereof, if any, and binding upon all beneficiaries thereunder, (c) that the Trustee, or any successor in trust, was duly authorized and empowered to execute and deliver every such deed, trust deed, lease, mortgage or other instrument and (d) if the conveyance is made to a successor or successors in trust, that such successor or successors in trust have been properly appointed and are fully vested with all the title, estate, rights, powers, authorities, duties and obligations of its, his or their presecessor in trust.

This conveyance is made upon the express understanding and condition that neither NAOMI L. BOILEK, individually, as Trustee, nor her successors in trust shall incur any personal liability or be subjected to any claim, judgment or decree for anything she or hereagenes or new claim, judgment or omit to do in or about the real estate or under the provisions of this Deed or the Trust Agreement or any amendment thereto, or for injury to person or property happening in or about the real estate, any and all such liability being hereby expressly waived and released. Any contract obligation or indebtedness incurred or entered into by the Trustee in connection with the real estate may be entered into in the name of the then beneficiaries under the Trust Agreement as her attorney in fact, hereby irrevocably appointed for such purposes, or at the election of the Trustee, in her own name, as Trustee of an express crust and not individually (and the Trustee shall have no obligation whatsoever, with respect to any such contract, obligation or indebtedness, except only so far as the Trust Property and funds in the actual possession of the Trustee shall be applicable for the payment and discharge thereof). All persons and corporations whomsoever and whatsoever shall be charged with notice of this condition from the date of the filing for record of this Deed.

The interest of each and every beneficiary hereunder and under the Trust Agreement and of all persons claiming under them or any of them shall be only in the earnings, avails and proceeds arising from the sale or any other disposition of the real estate, and such interest is hereby declared to be personal property, and no beneficiary hereunder shall have any title or interest, legal or equitable, in or to the real estate as such, but only an interest in the earnings, avails and proceeds thereof as aforesaid, the intention hereof being to vest in NAOMI L. BOILEK, as Trustee, the entire legal and equitable title in fee simple, in and to all of the real estate above described.

In the event that NAOMI L. BOILEK is unable to or refuses to act as Trustee, for any reason, then and in such event, STEPHEN C. BOILEK shall serve as Successor Trustee. In the event that both NAOMI L. BOILEK and STEPHEN C. BOILEK are unable to or refuse to act as Trustee, for any reason, then and in such event, SUSAN G. BOILEK shall serve as Successor Trustee.
