TO HAVE AND TO HOLD said premises with the appurtenances thereto upon the trusts, and for the uses and purposes herein and in said Trust set forth:

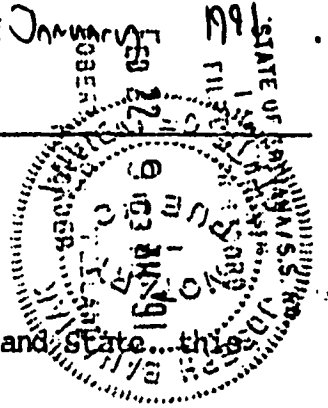
