This bond is given and received under the following express conditions:

That if the Surety shall so elect, this bond may be cancelled by giving thirty (30) days notice in writing to STATE OF INDIANA . . . and this bond shall be deemed cancelled at the expiration of thirty (30) days after such notice has been given, and said Surety remaining liable for all and any acts covered by this bond, which may have been committed by the Principal up to the date of such cancellation, under the terms, conditions and provisions of this bond, and the Surety shall, upon surrender of this bond and its release from all liability thereunder, refund the premium paid, less a pro-rata part thereof, for the time this bond shall have been in force;

That the Surety hereunder shall not be liable for any loss which may be sustained through the failure of any bank or banks or other depository to pay or deliver over any moneys and securities deposited with it by the said HELEN WALLACE . . . which may come into his hands by virtue of his said office.
