ORDER APPROVING EXECUTRIX'S FINAL PETITION TO SETTLE AND ALLOW ACCOUNT, PETITION FOR APPROVAL OF DISTRIBUTION OF ASSETS AND TO CLOSE ESTATE

This cause came to be heard on the 28th day of December, 1990, upon the Final Petition to Settle and Allow Account, Petition for Approval of Distribution of Assets and to Close Estate, filed by Barbara Rohde, as Executrix of the Estate of Ernest L. Rohde, deceased, which Petition is in the words and figures following, to-wit: (H.I.)

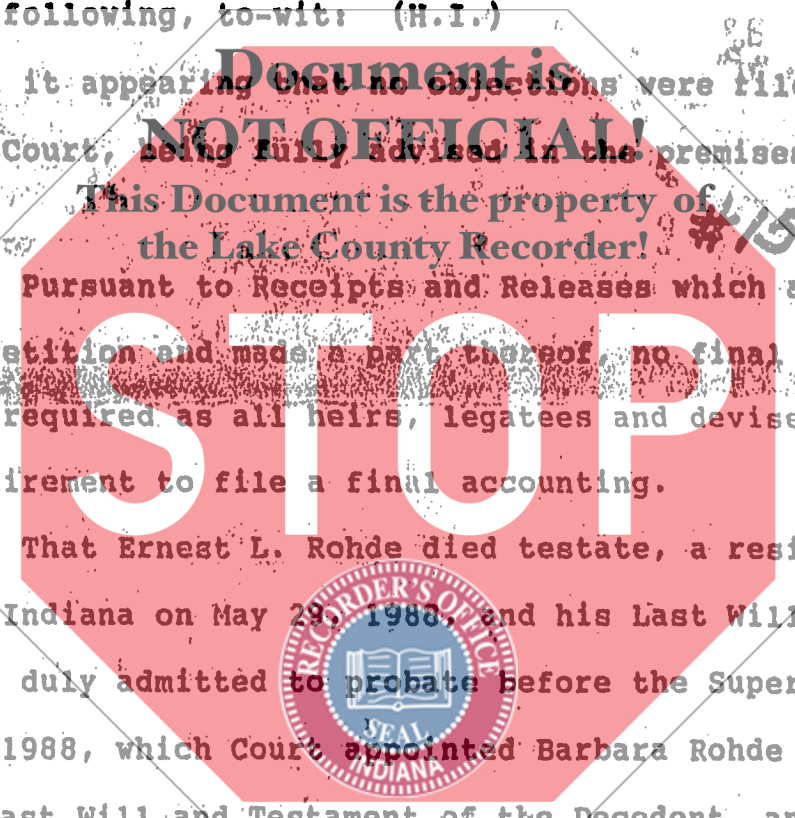
And it appearing that no objections were filed thereto, and the Court, being fully advised in the premises, now finds that:

1. Pursuant to Receipts and Releases which are attached to the Petition and made a part thereof, no final accounting will be required as all heirs, legatees and devisees have waived the requirement to file a final accounting.

2. That Ernest L. Rohde died testate, a resident of Lake County, Indiana on May 29, 1988, and his Last Will and Testament was duly admitted to probate before the Superior Court on June 7, 1988, which Court appointed Barbara Rohde Executrix of the Last Will and Testament of the Decedent, and said Executrix was issued Letters Testamentary on June 7, 1988, and has continued to serve in such capacity since that day.

3. That the matters and things stated in said Petition are true, and that said Executrix has accounted for all the assets in said Estate coming into her hands.

4. More than five (5) months have elapsed since the date of the first published notice to legatees, devisees and creditors of said Decedent; all claims filed against said Estate have been paid and discharged; neither said Decedent nor his Executrix were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said

Estate have been paid.

5. The following persons are the sole legatees and devisees under the Decedent's Last Will and Testament:

Barbara Rohde Dorothy Tucker

and that all assets and property of this Estate remaining after payment of Decedent's debts and expenses of administration have been distributed to the above-named persons, as evidenced by their respective Receipts and Releases which are all attached and made a part of said Petition.

6. The Decedent owned certain real estate located in Lake County, Indiana, more particularly described as follows:

Lot 185, Fifield's Forest Hills Addition to the Town of Merrillville, as shown in Plat Book 25, Page 3, in Lake County, Indiana.

Said real estate has not been disposed of during the administration of this Estate and title to the same now vests in Barbara Rohde and Dorothy Tucker pursuant to Item III of the Decedent's Last Will and Testament.

IT IS HEREBY ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. Said Final Petition to Settle and Allow Account, Petition for Approval of Distribution of Assets and to Close Estate is hereby in all things approved, settled and confirmed.

2. That the distribution of the balance of the property remaining in said Executrix's hands for distribution has been made as prescribed under the Last Will and Testament of the Decedent and is hereby in all things approved.

3. That pursuant to the Decedent's Last Will and Testament, the following described real estate, to-wit:

Lot 185, Fifield's Forest Hills Addition to the Town of Merrillville, as shown in Plat Book 25, Page 3, in Lake County, Indiana

is hereby vested in Barbara Rohde, as to an undivided one-half interest, and Dorothy I. Tucker, as to an undivided one-half interest, and that the Executrix is directed to record in the Office of the Recorder of Lake County, Indiana a copy of this Final Decree.

6. Said Executrix having made distribution of all assets and property and having attached Receipts to said Petition evidencing said distribution to said legatees and devisees, said distribution is hereby approved and confirmed.

7. Said Executrix is hereby released and discharged from any further liability or responsibility. This Estate is declared closed.

All of which is ordered this 28th day of December, 1990.
