- 2) To use and occupy the unit only as a private dwelling for the Grantee, his family and social guests and for no other purpose. No part of said premises shall be used as a boarding or lodging house, or for a school, or to give instructions in music or singing, and no part thereof shall be offered for rent by placing notices on any door, windows, or wall of the building. No part of said premises shall be used for any commercial or professional purposes, excepting occasional calls. The Grantee may let, or rent the unit and appurtenant occupancy rights to the full extent of his right and occupancy as defined in the Enabling Declaration, provided, however, no unit shall be so rented, let a subject without the written approval of all the remaining co-owners.
