Comes now Ernestine D. Green, Personal Representative named and appointed in the estate of said decedent, and shows to the Court that she did on the 15th day of February, 1991, file in this Court a Final Accounting, which Final Accounting is in these words (H.I.).

It is further shown that the sole beneficiary has submitted a Waiver and Consent to Personal Representatives Final Accounting.

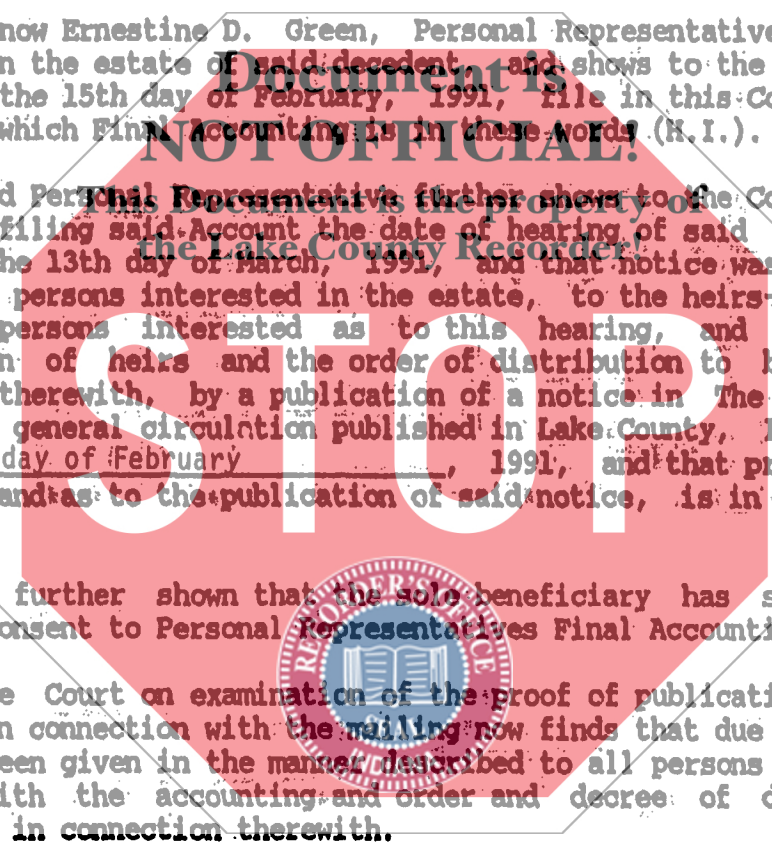
