LAKE County, Indiana, to wit:

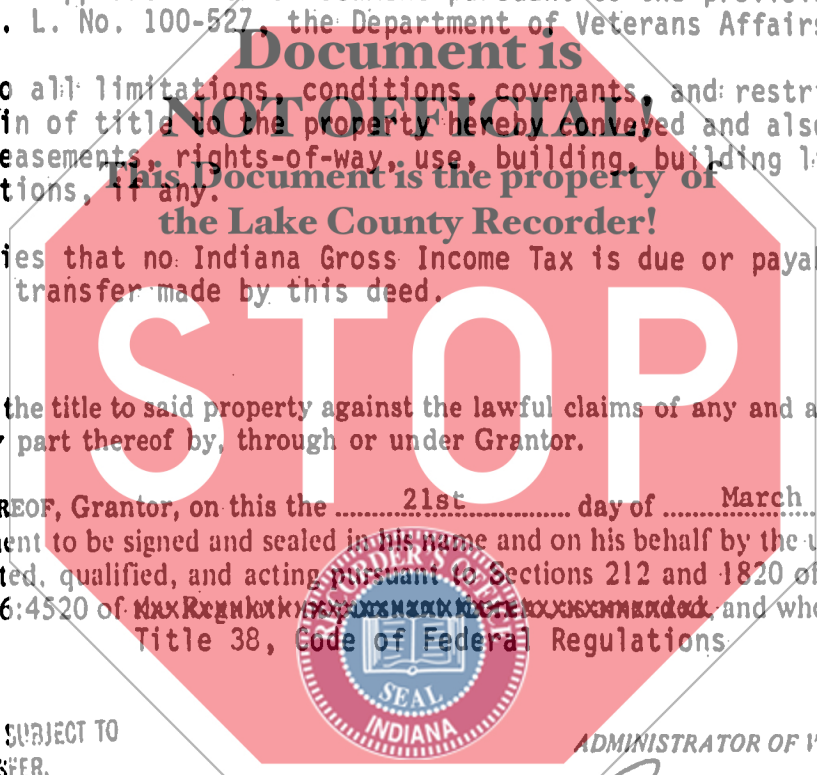
Lot 37 in Block 10, Tarry town Second Subdivision in the City of Gary,
