

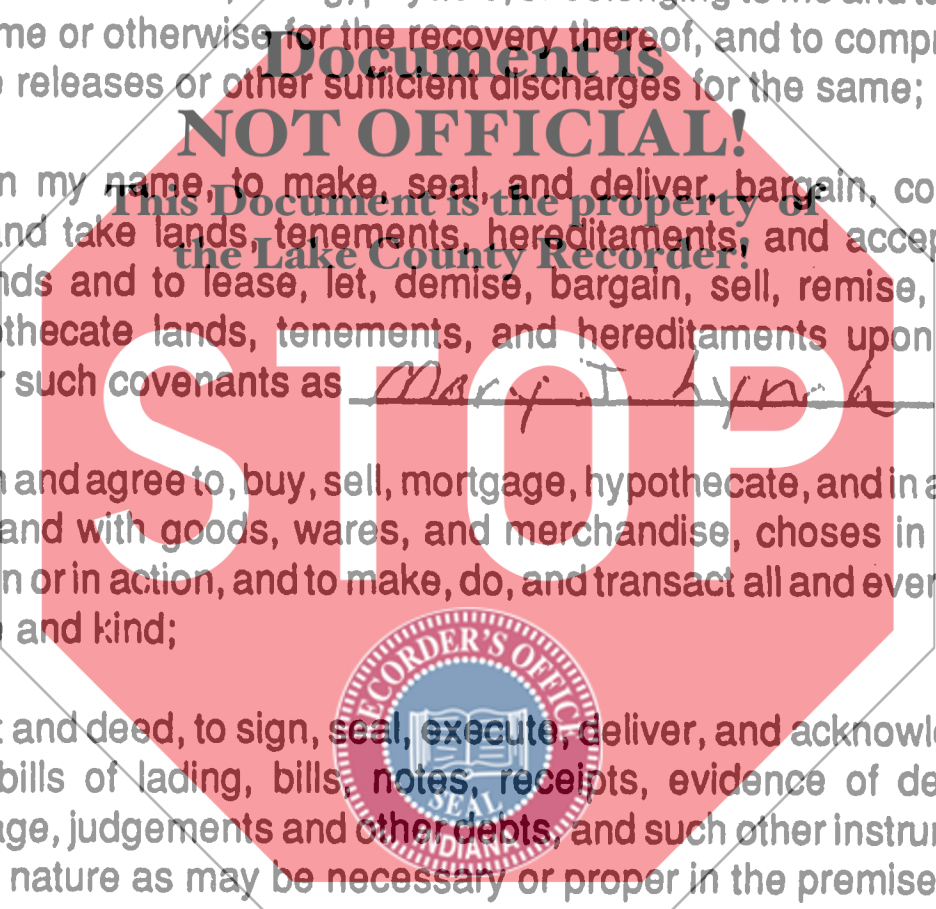

# Durable Power of Attorney

KNOW ALL MEN BY THESE PRESENTS that I, Hazel G. McElroy residing at 10270 N. Green, Danville, Ind., do hereby nominate, constitute and appoint Mary J. Lynch residing at 10280 N. Green, Danville, Ind., my true and lawful Attorney-in-fact, for me and in my name, place and stead, and for my use and benefit:

To ask, demand, sue for, recover, collect, and receive all sums of money, debts, dues, accounts, legacies, bequests, interest, dividends, annuities, and demands whatsoever as are now or shall hereafter become due, owing, payable, or belonging to me and take all lawful ways and means in my name or otherwise for the recovery thereof, and to compromise and agree to the same and give releases or other sufficient discharges for the same;



For me and in my name, to make, seal, and deliver, bargain, contract, agree for, purchase, receive, and take lands, tenements, hereditaments, and accept the deeds and possession of all lands and to lease, let, demise, bargain, sell, remise, release, convey, mortgage, and hypothecate lands, tenements, and hereditaments upon such terms and conditions and under such covenants as Mary J. Lynch shall think fit;

Also to bargain and agree to, buy, sell, mortgage, hypothecate, and in any and every way and manner deal in and with goods, wares, and merchandise, choses in action, and other property in possession or in action, and to make, do, and transact all and every kind of business of whatsoever nature and kind;

Also as my act and deed, to sign, seal, execute, deliver, and acknowledge such deeds, leases, mortgages, bills of lading, bills, notes, receipts, evidence of debt releases and satisfaction of mortgage, judgements and other debts, and such other instruments in writing whatsoever kind and nature as may be necessary or proper in the premises;

Also to endorse checks, notes, drafts and any other commercial paper in my name, and to withdraw money from any of my checking or savings accounts at any commercial bank, savings and loan association or other financial institution, and to sign orders or receipts therefore in my name;

And also to transfer any property held in my name into the Declaration of Trust dated \_\_\_\_\_, (The \_\_\_\_\_ Trust);

GIVING AND GRANTING unto my said attorney-in-fact full power and authority to do and perform every act necessary, requisite, or proper to be done in and about the premises as fully as I might or could do if personally present, with full power of substitution and revocation, hereby ratifying and confirming all that my said attorney-in-fact shall lawfully do or cause to be done by virtue hereof.
