All of which is ORDERED this 15 day of March, 1991.

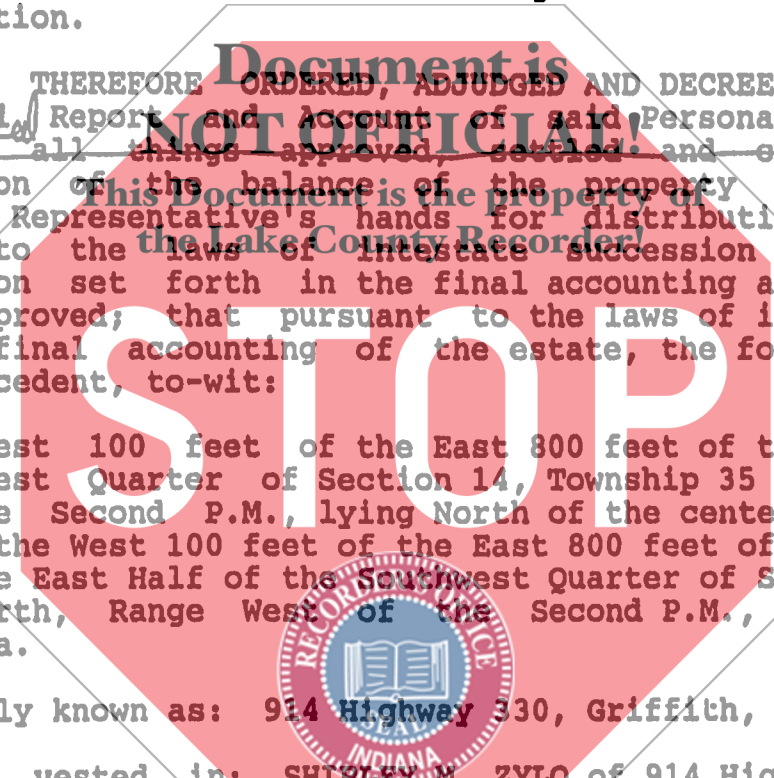
