PROVIDED FURTHER. that this bond shall be not construed to provide indemnity as a result of the Principal's failure to perform the terms of a construction contract.

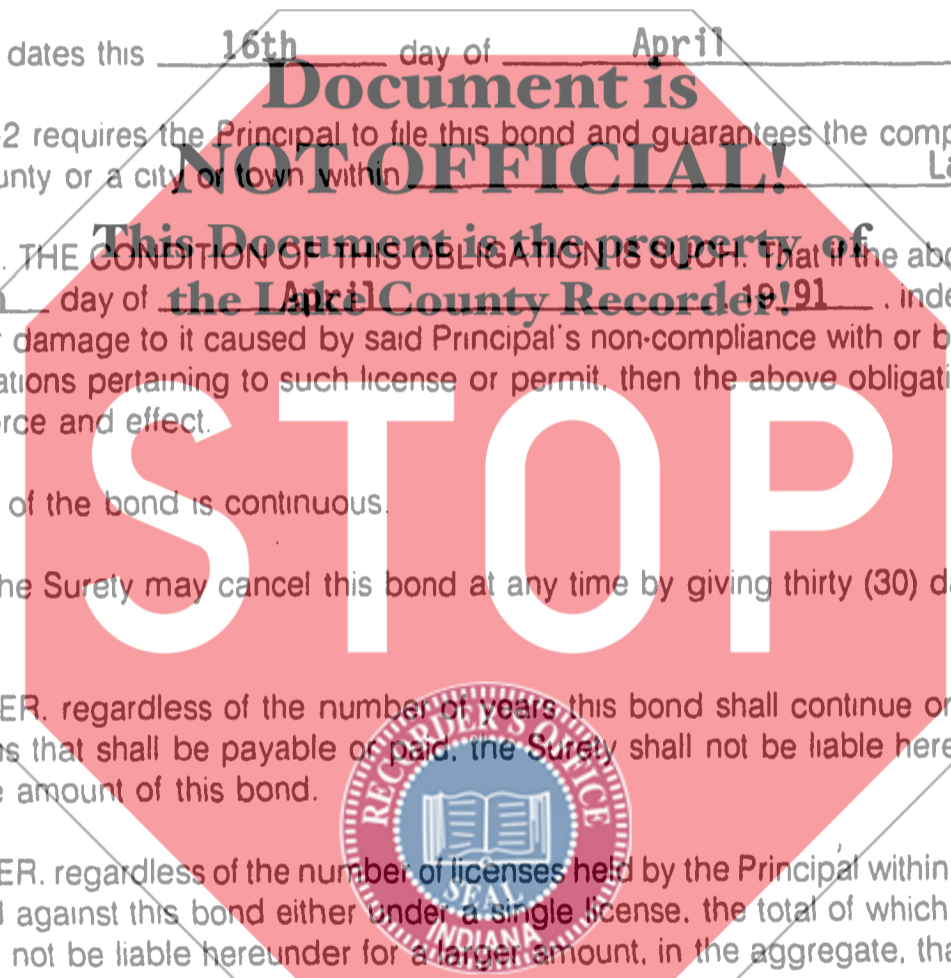

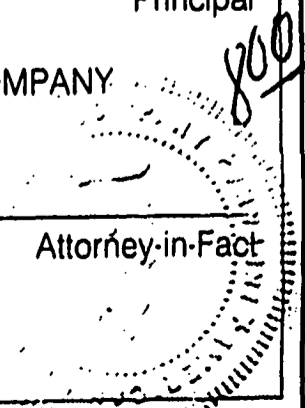
