(II) The Property is not occupied by the purchaser or grantee as his or her primary residence, or the purchaser or grantee does so occupy the Property but his or her credit has not been approved in accordance with the requirements of the Secretary.

(C) NO WAIVER. If circumstances occur that would permit Lender to require immediate payment in full, but Lender does not require such payments; Lender does not walve its rights with respect to subsequent events.

Any notice to Lender shall be given by first class mail to Lender's address stated herein or any address Lender designates by notice to Borrower. Any notice provided for in this Security Instrument. shall be deemed to have been given to Borrower or Lender when given as provided in this paragraph.

GOVERNING LAW SEVERABILITY This Security Instrument shall be governed by Federal law and the law of the jurisdiction in which the Property is located. In the evant that any provision or clause of this Security Instrument or the Note conflicts with applicable law, such conflict shall not affect other provisions of this Security Instrument or the Note which can be given effect without the conflicting provision. To this end the provisions of this Security Instrument and the Note are declared to be severable.

15. BORROWER'S CCPY. Borrower shall be given one conformed copy of this Security Instrument.

18. ASSIGNMENT OF RENTS. Borrower unconditionally resigns and transfers to Lender all the rents and revenues of the Property. Borrower authorizes Lender or Lender's agents to collect the rents and revenues and hereby directs each tenant of the Property to pay the rents to Lender or Lender's agents. However, prior to Lender's Notice to Borrower of Borrower's breach of any coveriant or agreement in the Security instrument, Borrower shall collect and receive all rents and revenues of the Property as trustee for the benefit of Lender and Borrower.
