2. Funds for Taxes and Insurance. 



INTEREST, RATE AND MONTHLY PAYMENT CHANGES!

The Note has an Initial Interest Rate of 8.75. %. The Note interest rate may be increased or decreased on the first day of the month beginning on May 1 , 1996 and on that day of the month every twelve (12) months thereafter. Each date on which the interest rate may change will be called a "Change Date."

Changes in the interest rate will be based on changes in an interest rate index. The Index is the Monthly Average Yield on the U.S. Treasury Securities

Adjusted to a Gonstant Maturity of One Year?

Before each Change Date, the Note Holder will calculate the new interest rate by adding 2.50 percentage at least 30 but not more than 45 days prior to each Change Date. The Note Holder will round the new interest rate to the nearest one eighth of one percentage point.

The interest rate will not be changed by more than two (2) percentage points on any Change Date. The Note Holder will adjust the new interest rate so that the change in the interest rate will not be more than 13.75 %.
