2. That affiant, Jeannette M. Romischer, is the daughter and only other heir at law of said Donald W. Marconi.

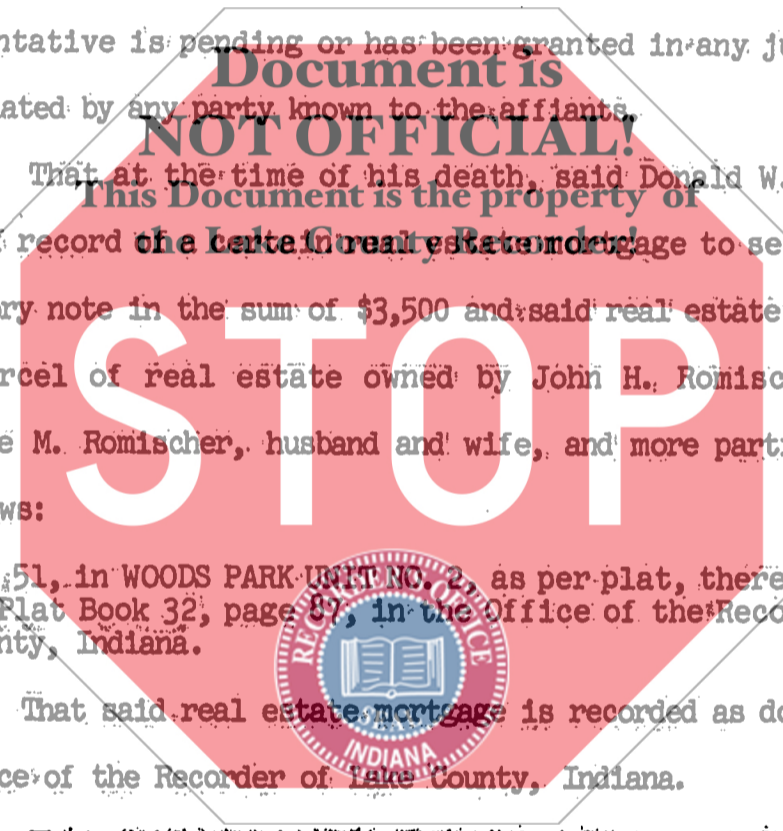

Marconi was the owner of record of the Lake County real estate mortgage to secure payment of a promissory note in the sum of \$3,500 and said real estate mortgage was held on a parcel of real estate owned by John H. Romischer and affiant, Jeannette M. Romischer, husband and wife, and more particularly described as follows:

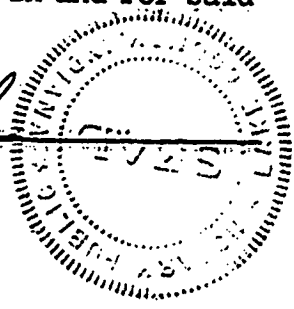
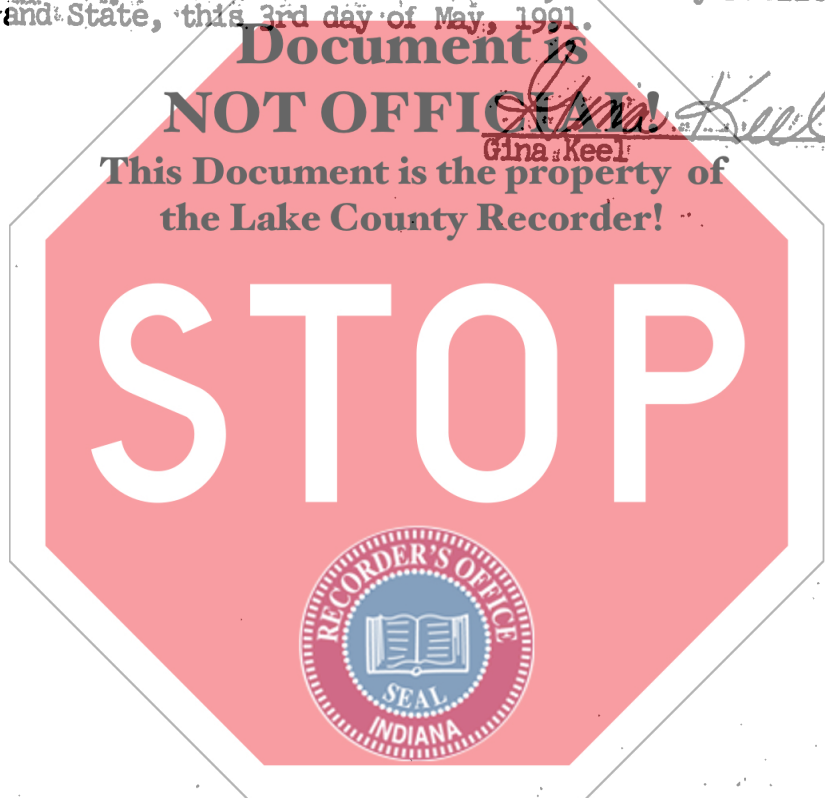
