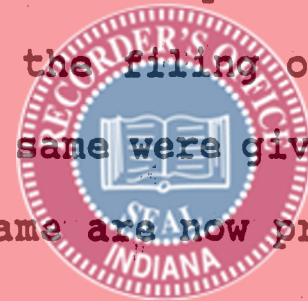
This matter comes before the court upon the verified

Administrator's Final Account, Petition to Settle and Allow
Account, Petition to Determine Heirship, and Petition for Authority
to Distribute Assets Remaining filed by John Saliwonczyk, which
Final Report, Account and Petition are in the words and figures
following, to-wit: (H. I.).

And it appearing that no objections were filed thereto and the
Court being fully advised in the premises, now finds as follows:

1. Due Notices of the filing of said Account and Petition
and of the hearing on the same were given to all persons interested
in said Estate and the same are now properly before the Court for
final action thereon.

2. That Tichon Saliwonczyk died intestate, a resident of
Lake County, Indiana on the 26th day of June, 1986, and this Court
then appointed John Saliwonczyk Administrator of the Estate of
Tichon Saliwonczyk and said Administrator was issued Letters of
Administration on the 29th day of May, 1987. Since that date he
has continued to serve as Administrator of said Estate.

3. That the matters and things stated in said Account and Petition are true and that said Administrator has accounted for all the assets in said Estate coming into his hands.

4. More than five (5) months have elapsed since the date of the first published notice to heirs and creditors of said decedent.

A claim was filed against said Estate but said claim, after disallowance, was resolved between the claimant and said Estate.

A copy of the dismissal of said claim has been filed in the Estate proceedings. All other bills and obligations of the decedent have

been paid and all costs of funeral and burial have been paid.

Neither said decedent nor his Administrator was an employer of labor within the meaning of that term as used in the Indiana

Employment Security Act. There were no Indiana Inheritance Taxes due in said Estate and no Federal Estate Taxes.

5. That the decedent died intestate and the persons claiming a relationship to the decedent were his four (4) children: Stanley

Saliweczyk, adult son; John Saliweczyk, adult son; Lydia Saliweczyk, adult daughter; Nancy Pachapa, adult daughter. That

during the administration of said Estate Lydia Saliweczyk passed away leaving as her sole heir at law her adult daughter, Charlene

Rivera.

6. That the decedent owned a parcel of real estate which was a single family dwelling at 4173 Lincoln Street, Gary, Indiana,

which is legally described as follows, to-wit:

The South 45.23375 feet of the North 90.3375 feet of Lot 7, Block 2, in the Second Subdivision to Oakington Park, in the City of Gary, as per plat thereof, recorded in Plat

Book 11, page 32, in the Office of the Recorder of Lake County, Indiana. (Said real estate is more commonly known as 4173 Lincoln Street, Gary, Indiana). (Key No. 46-125-16).

7. Three (3) children of the decedent, namely, John Saliwarczyk, Nancy Pachapa and Charlene Rivera, as sole heir to Lydia Saliwarczyk, have assigned all of their right, title and interest in and to the Estate of Tichon Saliwarczyk to Stanley Saliwarczyk, which copies of said Assignments have been filed with the Court in these proceedings.

8. That said assets, namely, the real estate described above, should be distributed to Stanley Saliwarczyk, 4173 Lincoln Street, Gary, Indiana.

IT IS, THEREFORE, ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. Said Final Report and Account of said Administrator is hereby in all things approved, settled and confirmed.

2. That the distribution of the balance of the property remaining in said Administrator's hands should be distributed to Stanley Saliwarczyk. Said Estate consists solely of real estate and the real estate at 4173 Lincoln Street, Gary, Indiana and legally described as follows, to-wit:

The South 45.23375 feet of the North 90.3375 feet of Lot 7, Block 2, in the Second Subdivision to Oakington Park, in the City of Gary, as per plat thereof, recorded in Plat Book 11, page 32, in the Office of the Recorder of Lake County, Indiana. (Said real estate is more commonly known as 4173 Lincoln Street, Gary, Indiana). (Key No. 46-125-16).

is hereby vested in Stanley Saliwarczyk.

3. Said Administrator is hereby directed to procure and record in the Office of the Recorder of Lake County a certified copy of this Final Decree.

4. Said Administrator is hereby directed to file his Supplemental Report showing that he has complied with the terms of this Order and that said Administrator has in all things carried out the provisions of this Final Decree.
