NOTE AND MORTGAGE EXTENSION and MODIFICATION AGREEMENT

THIS AGREEMENT, entered into this 22nd day of April, 1991, by and between
MERCANTILE NATIONAL BANK OF INDIANA, in its corporate capacity, First Party, and
ANTHONY S. DANIELS and JUDITH A. DANIELS, husband and wife, Second Party,
WITNESSETH:

WHEREAS, on the 16th day of March, 1985, Second Party executed its
certain promissory note in the principal sum of FIFTY FIVE THOUSAND and NO/100
Dollars (\$55,000.00), which note is payable to the First Party in equal monthly
principal and interest payments of SIX HUNDRED THIRTY and 69/100 Dollars (\$630.69)
with interest at the rate of THIRTEEN and ONE-QUARTER per cent (13.25%) per annum,
and with the balance due and payable on or before May 1, 2000; and

WHEREAS, said note was secured by a mortgage of even date, executed by
the Second Party to MERCANTILE NATIONAL BANK OF INDIANA, in the sum of FIFTY FIVE
THOUSAND and NO/100 Dollars (\$55,000.00), said mortgage was recorded on March 22,
1985 as Document No. 796582 in the Office of the Recorder of Lake County, Indiana,

WHEREAS, it was the desire of the Second Party to modify the rate of
interest on the then principal outstanding balance of FIFTY FOUR THOUSAND ONE
HUNDRED SIXTY NINE and 86/100 Dollars (\$54,169.86) from THIRTEEN and ONE-QUARTER
per cent (13.25%) per annum as stated in the aforementioned note and mortgage, to
TEN and ONE-QUARTER per cent (10.25%) per annum, with monthly principal and interest
payments to be FIVE HUNDRED SIX and 43/100 Dollars (\$506.43) rather than SIX HUNDRED
THIRTY and 69/100 Dollars (\$630.69), with the principal and interest payments under
this agreement to begin June 1, 1991, and with the final balance to be due May 1,
1991 rather than May 1, 2000; and

WHEREAS, it is the desire of the Second Party to extend the time of paying
the present principal outstanding balance of this note in the amount of FIFTY
THOUSAND EIGHT HUNDRED THIRTY THREE and 37/100 Dollars (\$50,833.37) for a period
of TWENTY YEARS, from May 1, 1991 to April 1, 2011, with interest and principal pay-
ments due monthly in equal monthly installments of FOUR HUNDRED SEVENTY THREE and
84/100 Dollars (\$473.84), rather than FIVE HUNDRED SIX and 43/100 Dollars (\$506.43),
and with interest to be NINE and ONE-HALF per cent (9.50%) per annum rather than TEN
and ONE-QUARTER per cent (10.25%) per annum, with no change in interest rate should
employee Judith A. Daniels leave the bank's employ.

NOW THEREFORE, in consideration of the mutual benefits to be derived from the change in the rate of interest and the amount of the principal and interest payments of the aforementioned note and mortgage, as well as the change in date of final payment, it is hereby agreed that,

FIRST PARTY agrees that the aforementioned note and mortgage shall be modified as set out above with the interest rate to be NINE and ONE-HALF per cent (9.50%) per annum, the amount of payment to be FOUR HUNDRED SEVENTY THREE and 84/100 (\$473.84), and the principal and interest payments under this agreement are to begin May 1, 1991 with the final balance to be due April 1, 2011.

IT IS FURTHER agreed that all provisions of the note and mortgage herein referred to shall continue in full force and effect except as modified by this Agreement.
