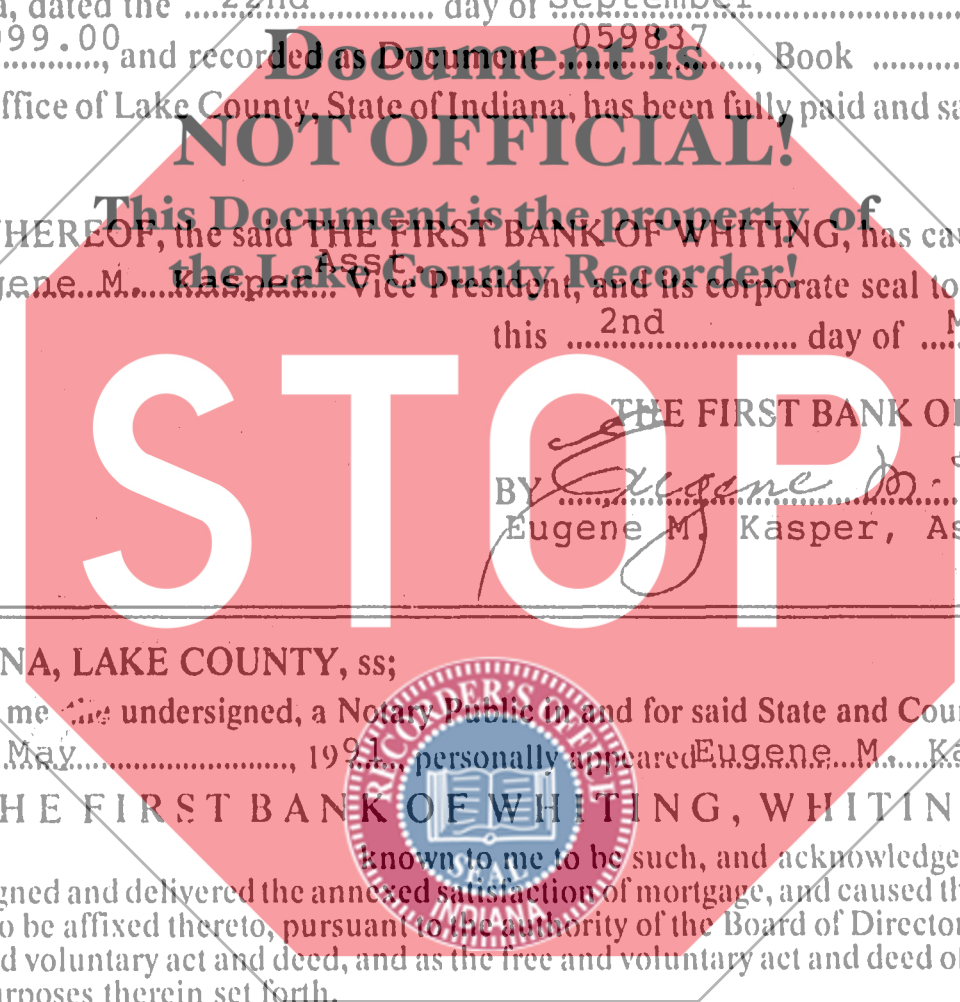

A parcel of land being a part of the Southwest Quarter of Section 20, Township 33 North, Range 9 West of the 2nd P.M. and a part of the Southeast Quarter of Section 19, Township 33 North, Range 9 West of the 2nd P.M. in Lake County Indiana, more particularly described as follows: Beginning at a point on the Section line between said Sections 19 and 20, 500.0 feet South of the Northeastern corner of the Southeast Quarter of said Section 19; thence North 89 degrees 08 minutes West for a distance of 239.70 feet to a point, that point being the center line of White Oak Street, thence South 05 degrees 24 minutes East along the center line of White Oak Street for a distance of 745.63 feet; to a point, thence South 15 degrees 22 minutes East along the center line of White Oak Street for a distance of 418.0 feet to a point; thence North 55 degrees 50 minutes East along the center line of a small stream for a distance of 70.8 feet; thence North 44 degrees 00 minutes East along the center line of the small stream for a distance of 56.0 feet thence North 18 degrees 00 minutes East along the center line of the small stream for a distance of 502.0 feet; thence North 41 degrees 00 minutes East along the center line of the small stream for a distance of 376.0 feet, thence North 35 degrees 00 minutes East along the center line of the small stream for a distance of 354.50 feet; thence North 89 degrees 08 minutes West for a distance of 644.0 feet to a point, that point being the point of beginning.
