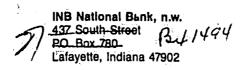

## Legal Description of Mortgaged Premises

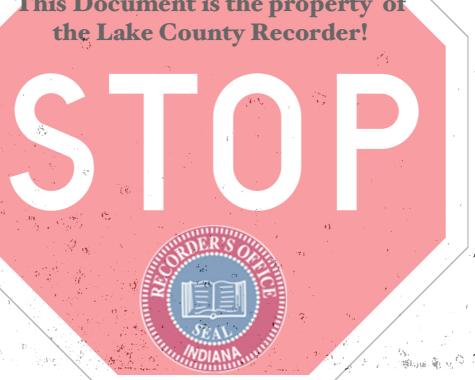
Situated in the City of Lowell, County of Lake, and State of Indiana, and is further described as follows:
