Comes now Richard Zuccolotto, being duly sworn upon his oath and states as follows:

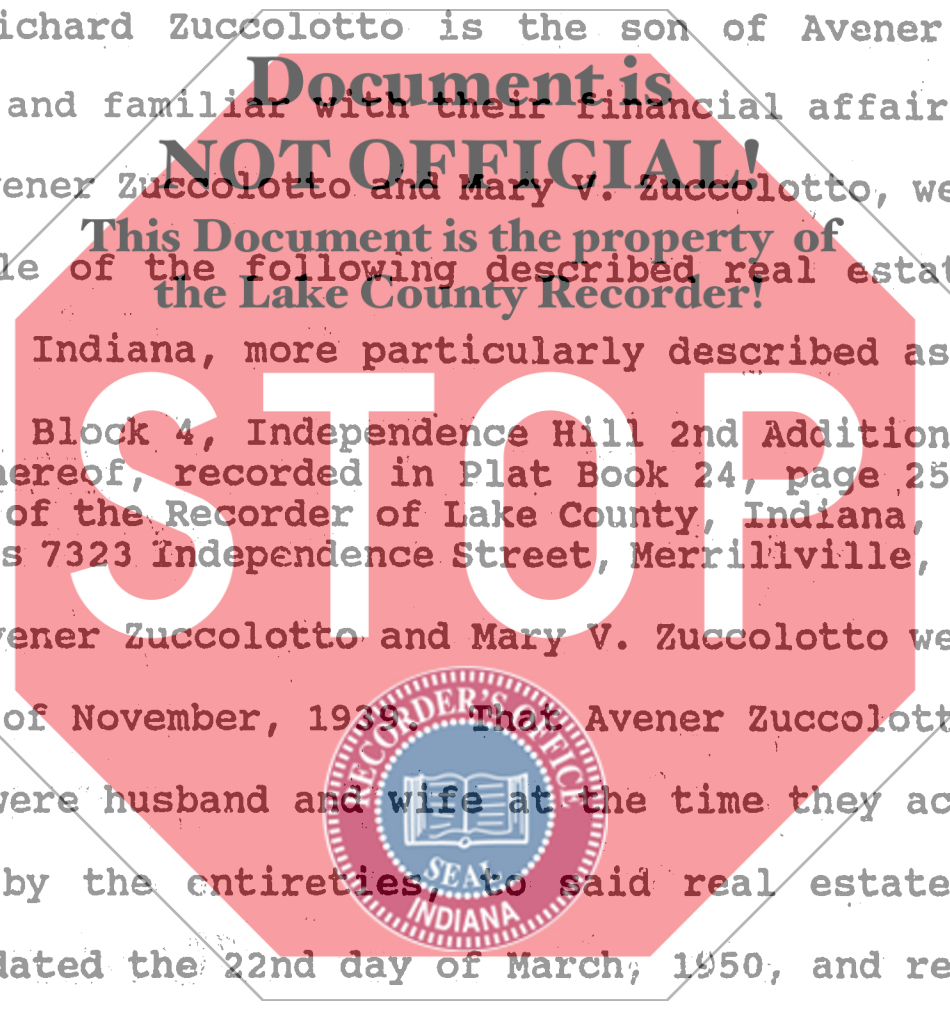
That Richard Zuccolotto is the son of Avener and Mary V. Zuccolotto, and familiar with their financial affairs.

That Avener Zuccolotto and Mary V. Zuccolotto, were the owners in fee simple of the following described real estate located in Lake County, Indiana, more particularly described as follows:

Lot 31, Block 4, Independence Hill 2nd Addition, as per plat thereof, recorded in Plat Book 24, page 25, in the Office of the Recorder of Lake County, Indiana, commonly known as 7323 Independence Street, Merrillville, Indiana.

That Avener Zuccolotto and Mary V. Zuccolotto were married on the 4th day of November, 1939. That Avener Zuccolotto and Mary V. Zuccolotto were husband and wife at the time they acquired title, as tenants by the entireties, to said real estate, by deed of conveyance dated the 22nd day of March, 1950, and recorded in the Office of the Lake County Recorder.

That the marital relationship which existed between Avener Zuccolotto and Mary V. Zuccolotto, continued unbroken from the time they so acquired title to said real estate until the death of Mary V. Zuccolotto, on the 16th day of March, 1986, at which time Avener Zuccolotto acquired title to the real estate as surviving tenant by the entireties.

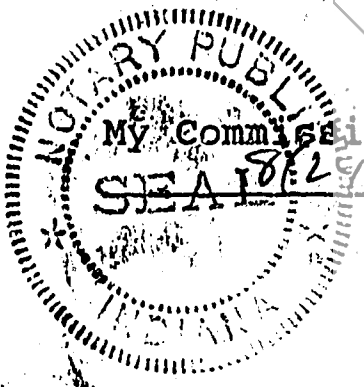
