This mortgage shall serve as notice to any and all persons that Mortgagors and BANK ONE have entered into a certain Equity Money Service Agreement dated April 27. 19 91 establishing a line of credit for Mortgagors in the amount of \$\frac{15,000.00}{15,000.00}\$ (the "Equity Money Service Agreement") which may be inspricted at the offices of BANK ONE by any interested persons. MORTGAGORS agree that:

- a. This mortgage is given to secure the payment of all indebtedness evidenced by or incurred pursuant to the Equity Monay Service Agreement now or in the future, beginning with the date of this mortgage and ending with the close of business on APTIL 27, 2011
- b. Interest on each advance shall accrue from the date made until repayment, at the rates agreed upon in the Equity Money Service Agreement.
- All advances shall be evidenced by the Equity Money Service Agreement and shall be payable without relief from valuation or appraisement laws, and with costs of collection to the extent permitted by law. Subject only to Mortgagors' billing error rights, the indebtedness secured by this mortgage from time to time shall be determined by BANK ONE's books and records.
- d. The word "advances" as used in this mortgage shall mean loans of money. In the event of any conflicts or inconsistencies between the terms of this mortgage and the terms of the Equity Money Service Agreement, the terms of the Equity Money Service Agreement shall control.

Mortgagors jointly and severally covenant and agree with BANK ONE that:

- 1. Mortgagers will pay all indebtedness secured by this mortgage when due, as provided in the Equity Money Service Agreement and in this mortgage, with attorneys' fees, and without relief from valuation or expraise ment laws.
- 2. The lien of this mortgage is prior and superior to all oth mortgage described as follows:
