THE ASSIGNOR covenants that there is due and owing on the Mortgage and Note, Bond or other evidence of obligation secured by the Mortgage, the Sum of **Twenty Thousand Seven Hundred Dollars & No/100 (\$20,700.00)** in principal, together with interest at the rate stated in the Note from **October 31, 1990**, with no set-offs, defenses or counterclaims against the same, in law or equity, nor have there been any modifications or other changes in the terms thereof, unless stated herein.
