1. That he is an adult-son of Joseph Chajmik, deceased.

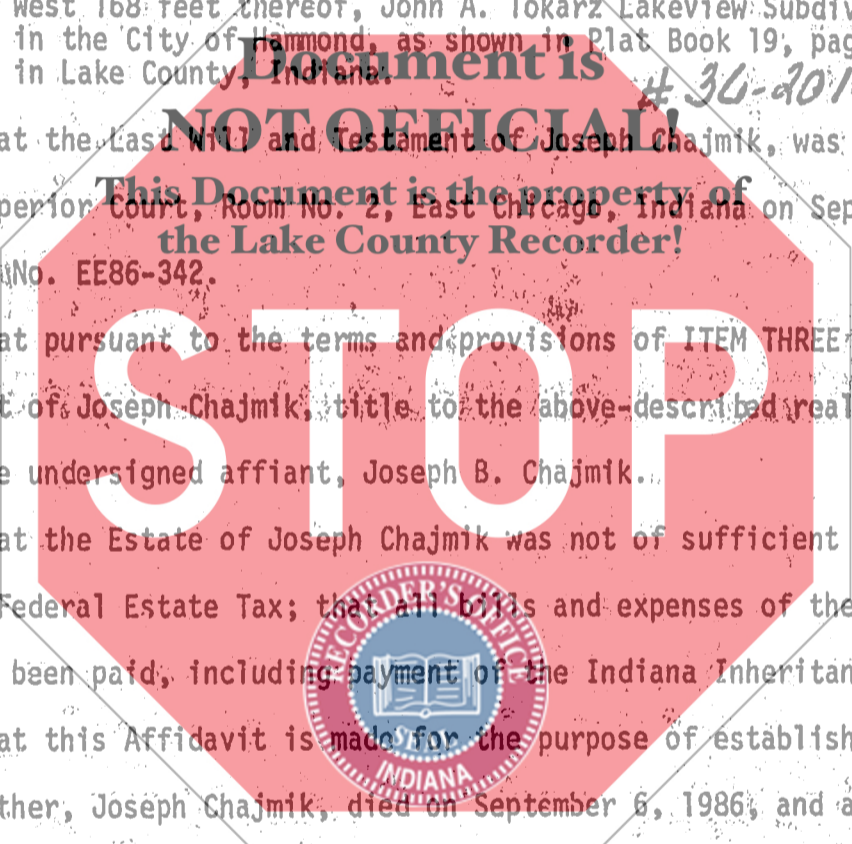
