AFFIDAVIT OF CHRIS D CONDES

I Chris D Condes, being first duly sworn upon my oath, depose and state that:

1. I was the President of Condes Realty Company, Inc. on April 8, 1968.

2. On April 8, 1968 I executed a Mortgage as President of Condes Realty Company, Inc. in the amount of \$18,000.00 to Condes-Retson, Inc. as recorded on April 13, 1968 in Mortgage Record 1694 page 357.

3. Condes-Retson, Inc. merged into Condes of Whiting, Inc. as recorded on December 28, 1973 as Articles of Merger as Document Number 234095.

4. I remained as Vice-President of Condes of Whiting, Inc. on January 1, 1974 after the merger of Condes-Retson, Inc. into Condes of Whiting, Inc. became effective.

5. In early 1979 I made a tender to obtain and purchase 100 per cent of all remaining stock interests from all stockholders of Condes of Whiting, Inc. that were not already owned and held by me personally.

6. The offer to purchase all outstanding interests of stock for Condes of Whiting, Inc. was accepted.

7. On July 1, 1979 I assumed total control of Condes of Whiting, Inc. by virtue of the purchase and closing transaction taking title to all outstanding stocks.

8. The aforementioned \$18,000.00 mortgage possibly held by Condes of Whiting, Inc. was not purchased or listed anywhere on closing statements as an asset that transferred to me upon taking ownership to Condes of Whiting, Inc.

9. The aforementioned mortgage for \$18,000.00 had been satisfied and paid in full prior to my taking possession of the outstanding stocks for Condes of Whiting, Inc.

10. After July 1, 1979 I held 100 per cent of all outstanding stock for the corporation Condes of Whiting, Inc. then which I allowed the corporation to become administratively dissolved without transferring, selling or giving up any rights of ownership.
