  2. In the amount of \$422.34 plus attorney's fees in the amount of \$400.00, plus costs in the amount \$24.00, plus direct, indirect and other expenses incurred in the amount of \$75.00, on Count Two of Plaintiff's Complaint;
- for a total Judgment in the amount of \$1139.38 plus post-judgment interest of ten percent (10%) per annum.

NOW THEREFORE, Judgment is hereby ordered entered in favor of Plaintiff, Reliable Supermarkets, and against Defendant, Judith Bosnick in the total amount of \$1139.38 plus ten percent (10%) interest from this date forward.


