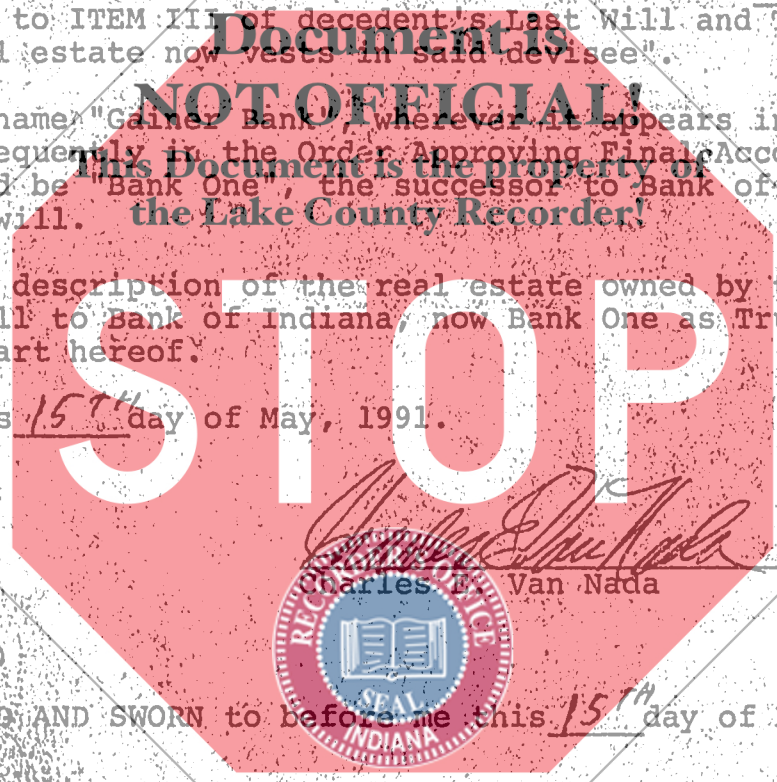
AFFIDAVIT

Charles E. Van Nada, being duly sworn on oath, states that he prepared the Personal Representative's Final Account for the Estate of Steven Traficanti, deceased, Estate No. 45CO1-9003-ES-084, Lake Circuit Court, which was filed in said Court on February 13, 1991. That in paragraph 5, page 2, of said Final Account, the name of the devisee of decedent's real estate is shown as "Bank of Indiana, now Gainer Bank, as Trustee, pursuant to ITEM III of decedent's Last Will and Testament, and title to said real estate now vests in said devisee".

The South Half of the Northwest Quarter; the North Half of Southeast Quarter; the North Half of Northeast Quarter of Southwest Quarter, all in Section 1, Township 33 North, Range 10 West of the Second Principal Meridian, in Lake County, Indiana. Key Nos. 1-84-3, 6 and 7.

The Northwest Quarter of the Southwest Quarter; That part of the South Half of Southeast Quarter of the Northwest Quarter; and of the Northeast Quarter of Southwest Quarter lying West of Swamp Land Ditch, in Section 6, Township 33 North, Range 9 West of the Second Principal Meridian, in Lake County, Indiana. Key Nos. 1-51-6, 11 and 12.
