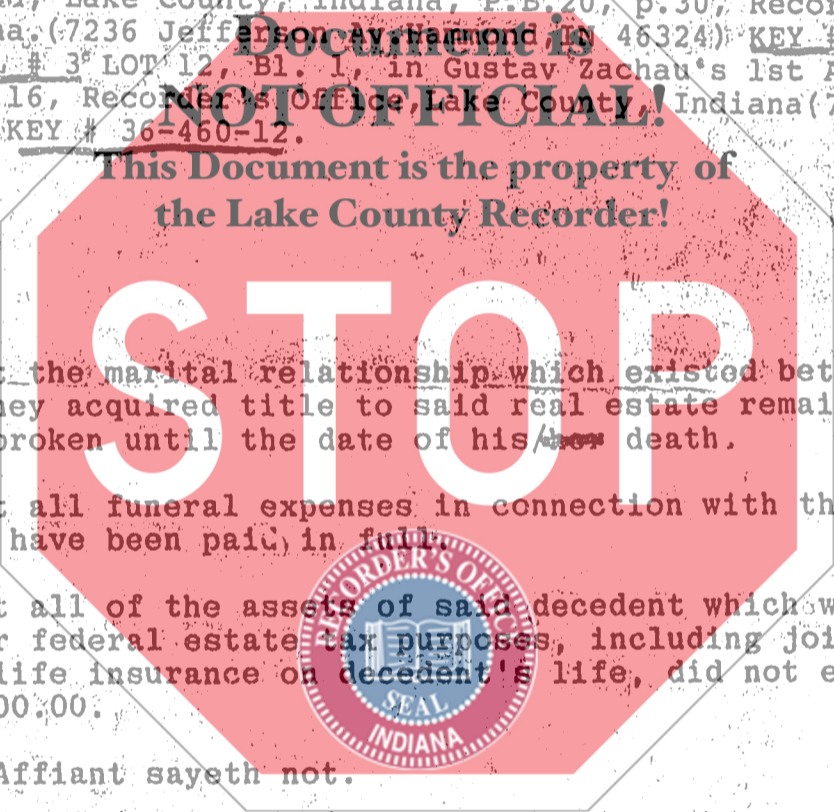

said decedent have been paid in full.

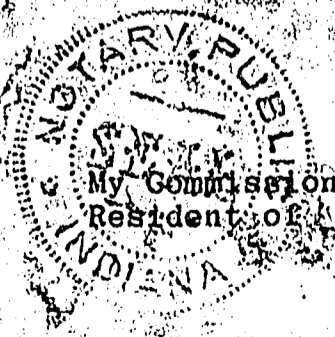
5. That all of the assets of said decedent which would be
