AN ORDINANCE VACATING A PORTION OF A STREET

WHEREAS, George Korellis and Harriet Korellis, resident freeholders of Hammond, Lake County, Indiana, have filed a Petition requesting the vacation of a portion of a street located adjacent to their property within the City of Hammond, Lake County, Indiana, legally described as:

Commencing at a point 100 feet North of the North right-of-way line of 167th Street at its intersection with the East right-of-way line of Hanson Place thence West a distance of 20 feet to a point 100 feet North of the North right-of-way line of 167th Street at its intersection with the West right-of-way line of Hanson Place thence North a distance of 321.60 feet thence in a Southeasterly direction a distance of 33.19 feet thence South a distance of 295.11 feet to the point of beginning.

WHEREAS, the Common Council of the City of Hammond, Indiana, upon investigation and hearing in accordance with law, finds and determines that the proposed vacation would not hinder the growth or orderly development of the City of Hammond or the neighborhood in which it is located or to which it is contiguous; and

The vacation will not make access to the lands of any persons by means of public way difficult or inconvenient; and

The vacation will not hinder the public's access to a church, school or other public building or place; and

The vacation will not hinder the use of a public way by the neighborhood in which it is located or to which it is contiguous.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF HAMMOND, LAKE COUNTY, INDIANA, THAT: it is desired and deemed necessary to vacate the following described street, to-wit:

Commencing at a point 100 feet North of the North right-of-way line of 167th Street at its intersection with the East right-of-way line of Hanson Place thence
