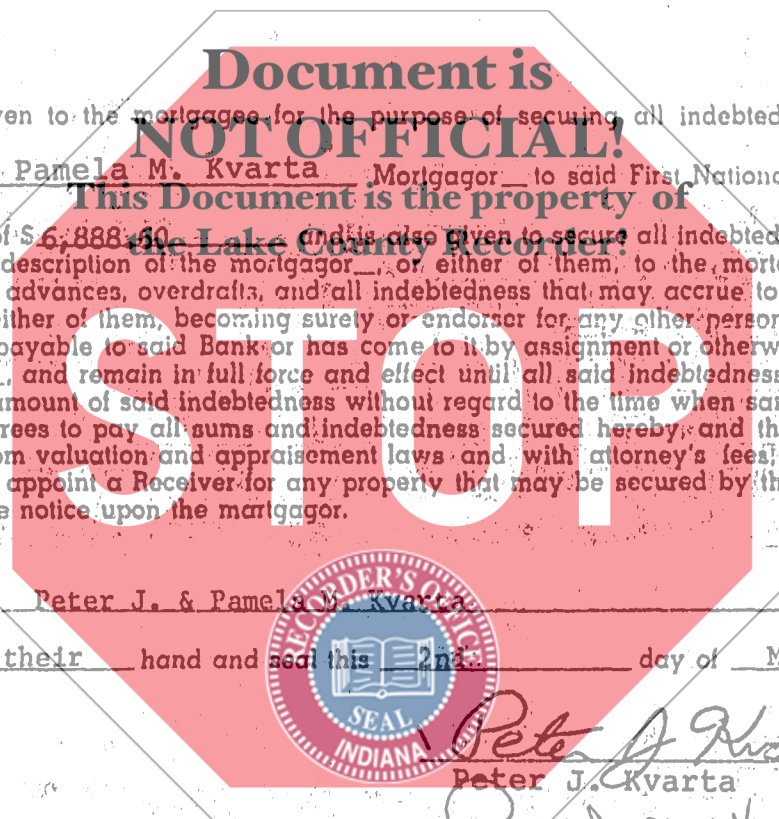
THIS INDENTURE WITNESSETH, THAT
