PARCEL 2: (Vacant parcel at 3321 Orchard Drive)

DESCRIPTION: Part of the South Half (according to acreage) of the West Half (according to acreage) of a 10 acre tract lying in that part of the Northwest Quarter (NW1/4) of the Northwest Quarter (NW1/4) of Section 15, Township 36 North, Range 9 West of the Second Principal Meridian described as follows: Beginning at Northeast corner of said NW1/4, NW1/4 and running thence West, the North line of said section 15, a distance 413.7 thence South, parallel with the East line of said NW1/4, NW1/4 932.9 feet to the center of a public highway; southeasterly, along the centerline of said highway, 481.3 feet to the East line of said NW1/4, NW1/4; thence North, along said East line 1173.5 feet to the place of beginning, containing 10 acres, more or less, in the CityUdfi Hammonds Lake County, Indiana and which part of said South Half of the West Half of said tra t is more particularly described as follows: Commenci Commencing at the Nor hwest corner of the aforesaid 10 acre tract: thence South, along the West line thereof, 490.38 Feet, more or less, to the Northwest corner tof the aforesatd South dialf of the West Half of 10 acre tract; thence east, along the North line of South Half of the West Half, 10.0 feet to the true point of thence southeasterly, 241.85 feet to a point which beginning; East of the West line of said 10 acre tract; 18.0 feet southwesterly, 169.35 feet to the point of intersection of the West line of said 10 acre tract with the Northerly 30 foot Right-of-Way line of Orchard Drive as described in a deed to the City of Hammond dated October 15, 1977 and recorded December 8, 1977 as Document in the Office of the Recorder of Lake County, Indiana; thence South along the West line of said 10 acre tract, 35.25 feet to the centerline of said Orchard Drive; thence Southeasterly, along said centerline, 93.32 feet, more of less, to a point on the extended West line of a parcel of Land conveyed to Jimmy L. Shirley A. Morgan by Warranty Deed recorded in Deed Record 1302, Page 337 in the Office of the Recorder of Lake County, Ir thence North, along said extended West line, a distance of Indiana; feet, more or less, to the Northwest corner of said Morgan parcel; thence East, along the North line and North line extended of Morgan parcel, 140.0 feet to a point on the East line of the West Half of said original 10 acre tract; thence North along said East 200.0 feet to the Northeast corner of the aforesaid South Half of the West Half of said original 10 acre tract; thence West, along the North line of said South Half of the West Half, 209.85 feet to the point of beginning, all in the City of Hammond, County, Indiana, excepting therefrom that part of the above described tract conveyed to the City of Hammond by deed dated October 15, 1977 and recorded December 8, 1977 as Document #443739.
