NOTE AND MORTGAGE EXTENSION AND MODIFICATION AGREEMENT

WHEREAS, it was the desire of the Second Party to extend the time of payment of the present principal outstanding balance of the aforesaid note in the amount of FORTY THOUSAND are No/too Dollars (\$40,000.00) from October 15, 1990 to April 15, 1991, with interest to remain 1% over the Chicago Prime Rate as announced by the First National Bank of Chicago to change the day following a change in the prime rate, per annum and with interest and principal payments due monthly in equal installments of SEVEN HUNDRED and NO/100 Dollars (\$700.00), with the first payment under this agreement to be due December 15, 1990 and the remaining payments on the 15th day of each calendar month thereafter.

WHEREAS, it is the desire of the Second Party to extend the time of the payment of the present principal outstanding balance in the amount of Thirty Eight Thousand, Five Hundred Fifty Six and 83/100 Dollars (\$38,556.83), for a period of SIX (6) MONTHS, from April 15, 1991 to October 15, 1991, with interest and principal payments to remain due monthly in equal installments of Seven Hundred and No/100 Dollars (\$700.00) at the rate of ONE per cent (1%) per annum, over the Chicago Prime Rate as announced by the First National Bank of Chicago to change the day following a change in the prime rate.

00/ E) NOW THEREFORE, in consideration of the mutual benefits to be derived from the extension of the time of payment, with no change in the interest rate of said note and mortgage referred to, it is hereby agreed that;

FIRST PARTY agrees that the interest rate of the note and mortgage herein referred to shall remain at ONE per cent (1%) per annum, variable, over the Chicago Prime Rate as stated above, and the time of payment extended as set out above.

IT IS FURTHER AGREED that all provisions of the note and mortgage herein referred to shall continue in full force and effect except as modified by this Agreement.
