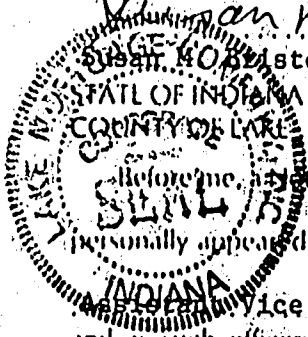

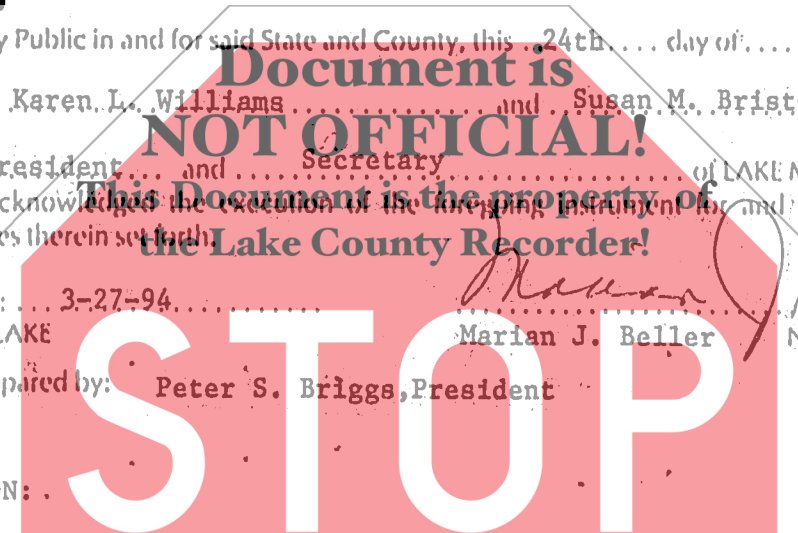

LEGAL DESCRIPTION:

THE WEST 76 FEET OF THE EAST 168 FEET, MEASURED ALONG MAIN STREET, OF THE FOLLOWING DESCRIBED TRACT OF LAND, TO-WIT: A PART OF THE NORTHWEST QUARTER OF THE SOUTHWEST QUARTER OF SECTION 23, TOWNSHIP 33 NORTH, RANGE 9 WEST OF THE SECOND PRINCIPAL MERIDIAN, DESCRIBED AS FOLLOWS, TO-WIT: COMMENCING AT A POINT ON THE NORTH LINE OF MAIN STREET 20 FEET EAST OF THE SOUTHEAST CORNER OF LOT 6, AS MARKED AND LAYED DOWN ON THE RECORDED PLAT OF HIGHLAND ADDITION TO THE TOWN OF LOWELL, INDIANA, WHICH POINT IS THE EAST LINE OF THE ALLEY SHOWN AND DESIGNATED ON THE RECORDED PLAT OF HIGHLAND ADDITION TO LOWELL; THENCE EASTERLY ALONG THE NORTH LINE OF MAIN STREET 208 FEET; THENCE NORTH AND NORTHWESTERLY BY A CURVE OF 200 FOOT RADIUS TO A POINT 98 FEET NORTH OF AND 182 FEET EAST OF THE POINT OF BEGINNING; THENCE NORTHWESTERLY 140 FEET, MORE OR LESS, TO A POINT 218 FEET NORTH OF AND 114-1/2 FEET EAST OF THE POINT OF BEGINNING; THENCE WEST AND PARALLEL WITH THE NORTH LINE OF SAID MAIN STREET 223 FEET, MORE OR LESS, TO THE EAST LINE OF THE 20 FOOT ALLEY AFORESAID; THENCE SOUTHWESTERLY ALONG THE EASTERLY LINE OF SAID ALLEY 244 FEET, MORE OR LESS, TO THE POINT OF BEGINNING, SAID WEST LINE OF THE LOT HEREIN DESCRIBED TO BE DUE NORTH AND SOUTH AND TO EXTEND FROM THE NORTH LINE OF MAIN STREET TO WHERE SAID NORTH AND SOUTH LINE WOULD INTERSECT SAID NORTH LINE OF THE ENTIRE LOT SO ABOVE DESCRIBED, IN LAKE COUNTY, INDIANA.
