## LOAN MODIFICATION AGREEMENT

WHEREAS, Citizens Federal Savings and Loan Association of Hammond, Indiana (Lender) loaned Donald L. Earley and Mary E. Earley (Borrower), the sum of Forty Five Thousand Dollars (\$45,000.00) as evidenced by a Note, supplemented by a Rider to Mortgage Note (Note Rider), each executed by Borrower on May 16, 1984;

WHEREAS, the Borrower has requested a modification of the terms of said loan for the purpose of reducing the interest rate from 12.00to 9.25%, reamortizing monthly principal and interest payments over a remaining term of 194 months and extending the balloon maturity date of said loan from July 1, 1993 to May 1, 1996; and,

WHEREAS, in consideration of Lender's consent to the above-described terms, Borrower shall pay to Lender a Loan Fee of \$413.67, which fee is 1% of the outstanding loan balance and a Processing Fee of \$100.00;

THEREFORE, it is hereby agreed that the terms of said loan as modified are as follows:

- Borrower promises to pay to Lender the outstanding principal balance of Forty One Thousand Three Hundred Sixty Six Dollars and Sixty Cents (\$41,366.60) with interest at a rate of 9.25% per year.
- 2. Principal and interest payments shall be paid in Fifty Nine (59) consecutive monthly installments of Four Hundred Eleven Dollars and Sixty Eight Cents (\$411.68) beginning June 1, 1991 and a final balloon payment of the outstanding loan balance will be due and payable in full on May 1, 1996.
- Borrower shall pay to Lender a Loan Fee of \$413.67, the receipt of which is hereby acknowledged.
- 4. Borrower shall pay to Lender a Processing Fee of \$100.00, the receipt of which is hereby acknowledged.
