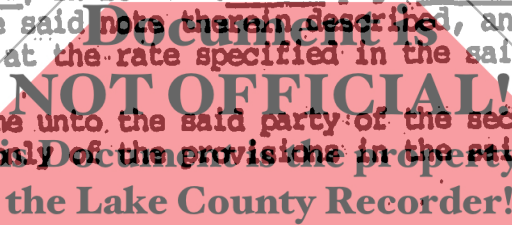

Lot 13, Block 4, Woodlawn Addition to Griffith, as shown in Plat book 21 page 15, in Lake County, Indiana.

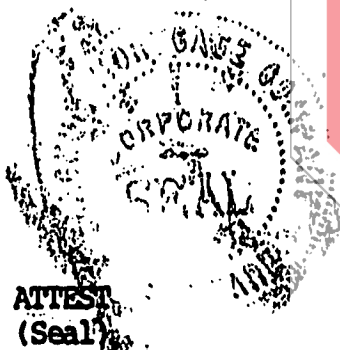
