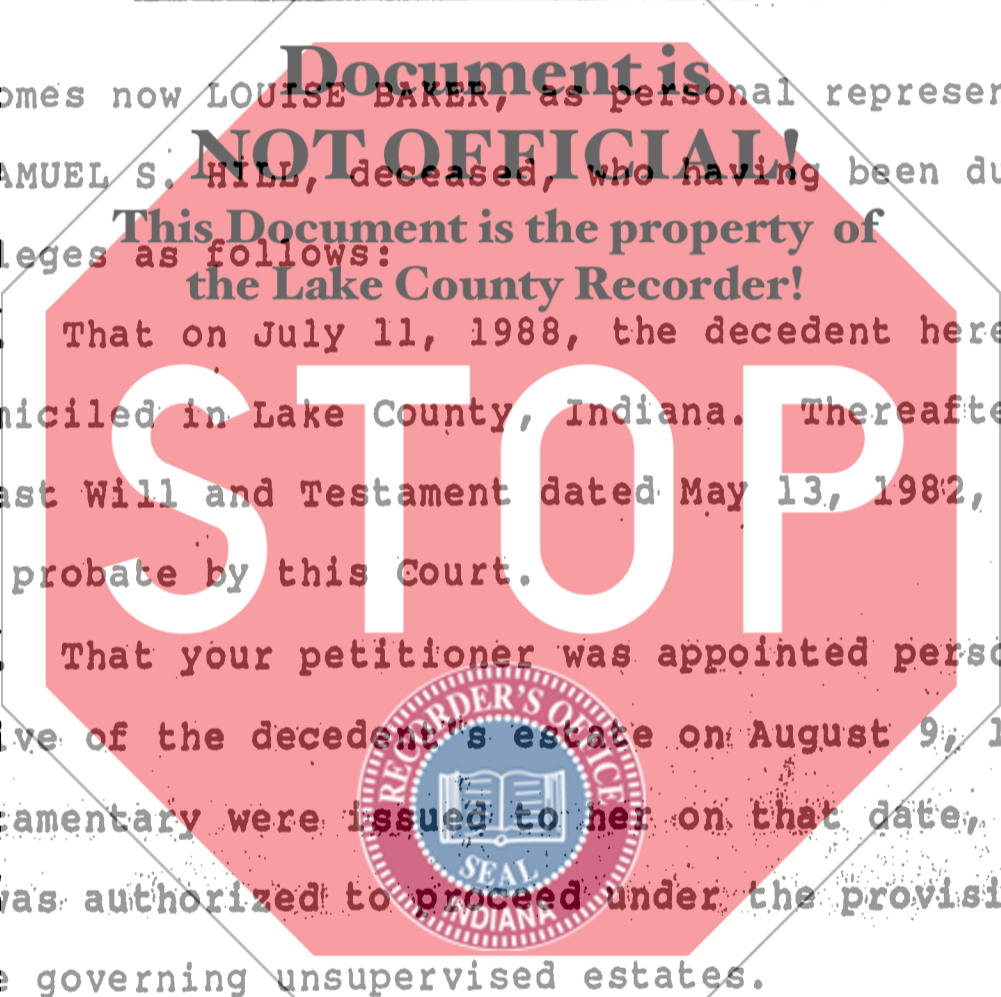

1. That on July 11, 1988, the decedent herein died testate, domiciled in Lake County, Indiana. Thereafter on August 9, 1988, his Last Will and Testament dated May 13, 1982, was duly admitted to probate by this Court.
2. That your petitioner was appointed personal representative of the decedent's estate on August 9, 1988, and Letters Testamentary were issued to her on that date, and said petitioner was authorized to proceed under the provisions of the Indiana Code governing unsupervised estates.
3. That notice of her appointment as personal representative of the estate of Samuel S. Hill was first published to creditors on August 18, 1988, in the Lake County Globe Ledger and that five (5) months have elapsed since the first published notice to creditors.

4. That the petitioner has fully administered the estate of the decedent in that she has collected all the assets of the estate that have come to her knowledge, filed all required Federal Estate and Income Tax Returns, Indiana Income and Inheritance Tax Returns and paid all taxes. A copy of the countersigned Inheritance Tax Receipt is attached hereto as Exhibit "A".

5. That no claims were filed in the decedent's estate.

6. That all the assets of said estate have been administered upon and no reason exists why this estate cannot be closed at this time. That said petitioner is the sole distributee under decedent's Will and hereby consents to this closing statement and the accounting attached hereto as Exhibit "B".

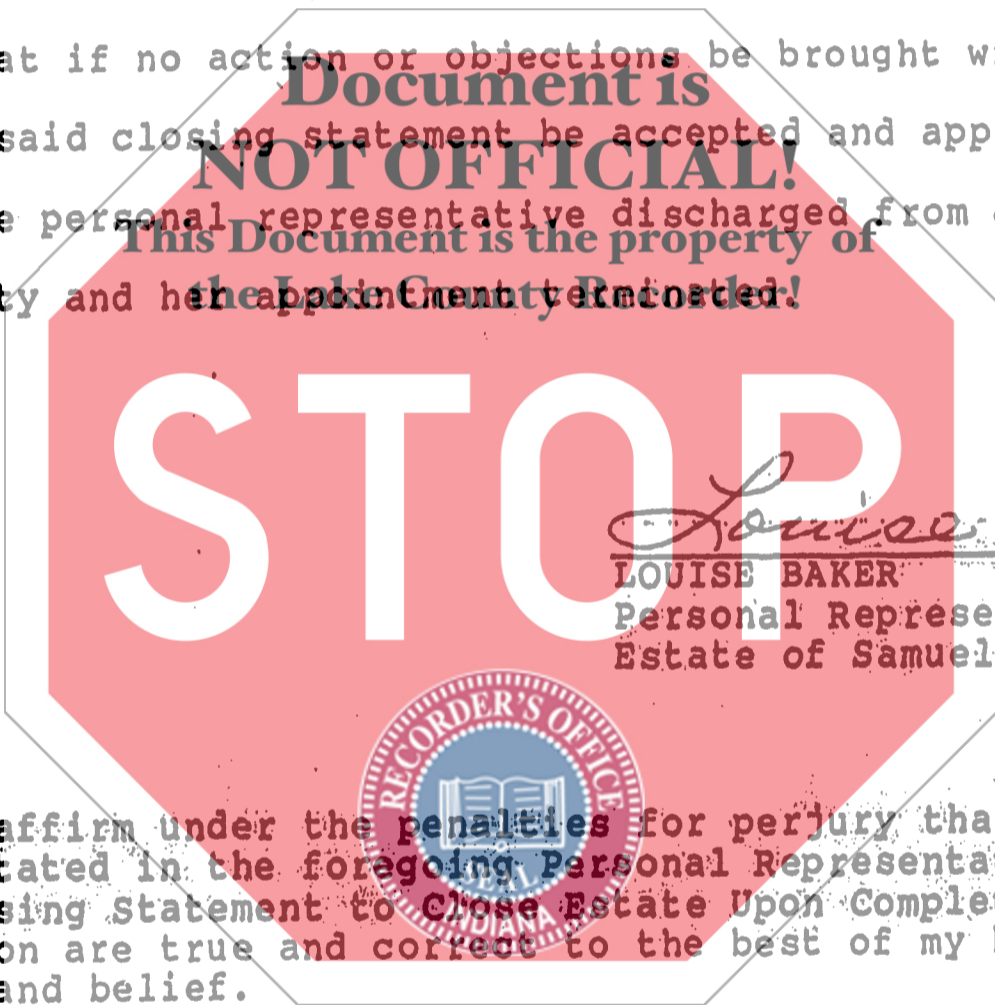
