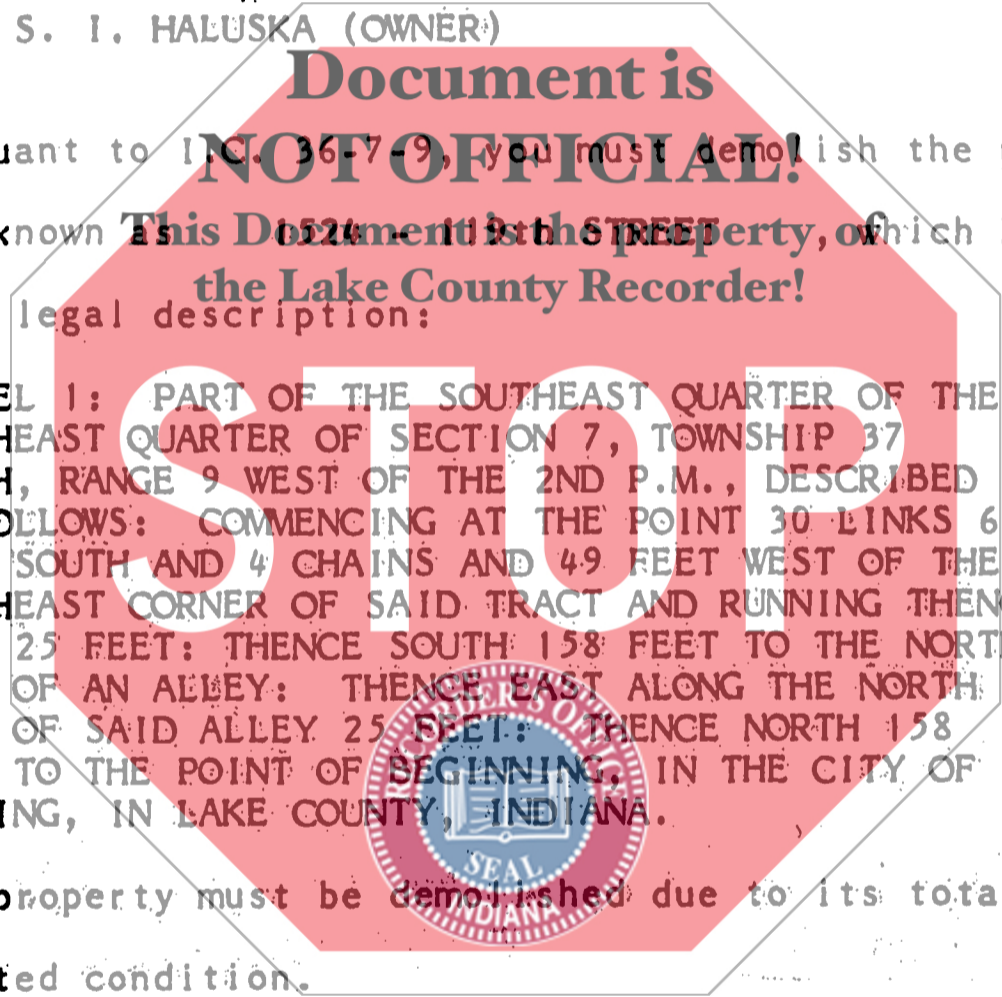

If you fail to comply with the above Order, and this Order is affirmed at the hearing, the City of Whiting Building Commissioner may have the Order carried out by a contractor licensed and qualified under the laws of Indiana and a lien recorded against the owner(s).

You are hereby notified that it is your obligation under I.C. 36-7-9-27 to provide the Building Commissioner of the City of Whiting, Indiana, with a full name, address and telephone number of any person taking a substantial property interest in the unsafe premises within five (5) days after transferring or agreeing to transfer such an interest. Also, you are obligated to supply the Building Commissioner with a written copy of the legal instrument under which the transfer or agreement to transfer the substantial property interest is accomplished.

In addition, you are obligated to supply full information regarding this order to any person who takes or agrees to take a substantial property interest in the unsafe premises before transferring or agreeing to transfer that interest.

You have a right to appear at the hearing of this cause with or without legal counsel. You also have the right to present evidence in your favor, to cross-examine opposing witnesses, and to present your views regarding this particular matter.
