M., DESCRIBED AS FOLLOWS: COMMENCING AT A POINT 30 LINKS 6 FEET SOUTH AND 4 CHAINS AND 49 FEET WEST OF THE NORTHEAST CORNER OF SAID TRACT AND RUNNING THENCE WEST 25 FEET; THENCE SOUTH 158 FEET TO THE NORTH LINE OF AN ALLEY; THENCE EAST ALONG THE NORTH LINE OF SAID ALLEY 25 FEET; THENCE NORTH 158 FEET TO THE POINT OF BEGINNING, IN THE CITY OF WHITING, IN LAKE COUNTY, INDIANA.
