

RELEASE OF EASEMENT FOR ELECTRICAL & GAS LINES

THIS INDENTURE WITNESSETH: That Northern Indiana Public Service Company, an Indiana corporation, the holder of an easement for Electrical and Gas Lines executed by Sydney E. Garner and Sarah F. Garner, husband and wife dated July 2, 1954, recorded July 8, 1954, in Book Misc 615, Page 323, in the Recorder's Office of Lake County, Indiana, in consideration of One Dollar (\$1.00) in hand paid, the receipt whereof is hereby acknowledged does hereby REMISE, RELEASE AND FOREVER QUIT CLAIM to Sydney E. Garner and Sarah F. Garner and to their successors and assigns, all the right, title and interest acquired under the aforesaid easement for electrical lines and gas lines in, upon, along and over the premises situated in Lake County, Indiana, described as follows:

A strip of land 5 ft. wide on either side of center line starting at a point 935.0 feet East and 175.34 feet North of the Southwest corner of Section 8, Township 34 North, Range 8 West and continuing Westerly parallel to the South line of said Section 8 for a distance of 935.0 feet in the following described property: Part of the Southwest Quarter (SW $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) of Section 8, Township 34 North, Range 8 West of the Second Principal Meridian, Lake County, Indiana, more particularly described as follows: Commencing at the Southwest corner of the above said Southwest Quarter (SW $\frac{1}{4}$) of the Southwest Quarter (SW $\frac{1}{4}$) and running thence East 935.0 feet, thence North 544.80 feet, thence Westerly 935.19 feet, thence South 526.02 feet to the point of beginning.

Also the East 35 feet of the above described parcel of land.
