upon the Final Account and Petition to Settle and Allow and For Authority to Distribute Estate filed by John Michael Rusbasan Jr. and William L. Rusbasan, Co-Administrators With Will Annexed of the Estate of Sylvia Rusbasan, deceased, which account and petition are in the words and figures following, to-wit: (H.I.)

And it appearing that no objections were filed thereto and the Court being fully advised in the premises now finds:

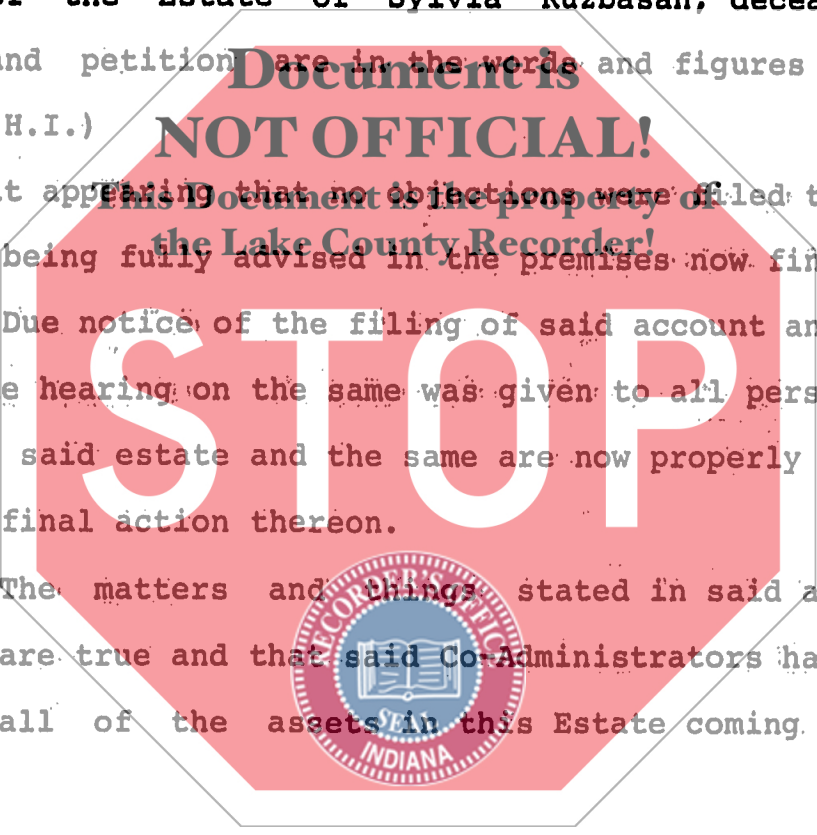
1. Due notice of the filing of said account and petition and of the hearing on the same was given to all persons interested in said estate and the same are now properly before the Court for final action thereon.
2. The matters and things stated in said account and petition are true and that said Co-Administrators have accounted for all of the assets in this Estate coming into their hands.
3. More than five (5) months have elapsed since the date of the first publication of notice to the heirs and creditors of said decedent; all claims filed against said Estate have been paid and discharged; neither said decedent nor these Co-Administrators were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; all Inheritance and Income Tax found due has been paid; the estate was not subject to Federal Estate Tax.
4. The Co-Administrators have waived their fee.

IT IS THEREFORE ORDERED, ADJUDGED AND DECREED by the Court as follows:

1. Said account and petition of said Co-Administrators is hereby in all things approved, settled, allowed and confirmed.

That after payment of those remaining debts, taxes and expenses listed in paragraph 3 (a) through (d), inclusive, of their Final Account, these Co-Administrators are hereby ordered and directed to pay over and distribute the remaining assets in their hands, including any interest the estate may have in the Harriet McKean Trust which is now on appeal in the Appellate Court of Illinois, and has been estimated at between \$11,000.00 and \$25,000.00 and nothing if the appeal is resolved favorably to the appellant, to John Michael Ruzbasan Jr. and William Leslie Ruzbasan, equally, except the share of William Leslie Ruzbasan shall be charged for distribution to him of a 1980 Chevrolet valued at \$600.00.

The decedent died seized of the following described real estate in Lake County, Indiana, of which no sale or disposition was made during the period of this administration:


Lot 25, Block 7, The Meadowdale Subdivision, as shown in Plat Book 31, Page 52, Lake County, Indiana

3. The Co-Administrators have waived their fees.

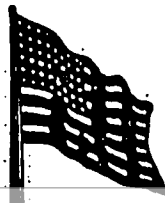
