TROCHA died intestate, a resident of Lake County, Indiana, on May 12, 1990; that on June 27, appointed Deborah Trocha as Personal Representative of the Decedent's Estate, and Letters of Administration were issued, and she has continued to act as Personal Representative since the opening of this Estate.
