to be made, we bind ourselves and our legal representatives, jointly and severally.

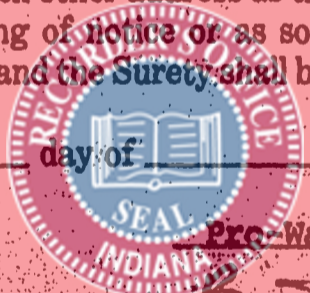
THE CONDITION OF THIS OBLIGATION IS SUCH, That whereas, the Principal has been

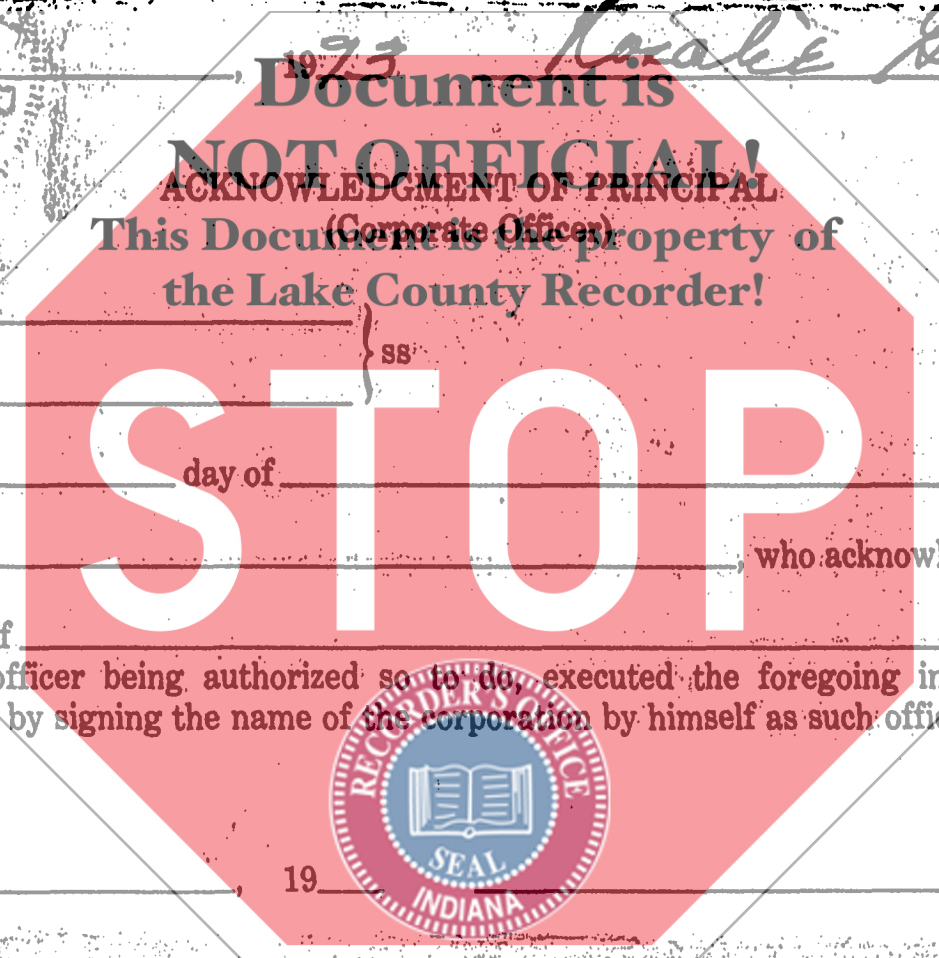
