



A part of the West Half of the Southwest Quarter of Section 30, Township 33 North, Range 8, West of the 2nd Principal Meridian, more particularly described as follows: Commencing at the intersection of the West line of said Section with the center line of the public highway known as the State Road (crossing said Section in a Northeasterly and Southwesterly direction) and running thence North following the West line of said Section for a distance of 532.40 feet; thence East 379.9 feet; thence South 339.70 feet to the center line of said State Road; thence Southwesterly along the center line of said State Road, a distance of 431 feet to the placer of beginning, in Lake County, Indiana, except therefrom the West 30 feet and the Southerly 30 feet.
