4. Fire, Flood and Other Hazard Insurance. Borrower shall insure all improvements on the Property, whether now in existence or subsequently erected, against any hazards, casualties, and contingencies, including fire, for which Lender requires insurance. This insurance shall be maintained in the amounts and for the periods that Lender requires. Borrower shall also insure all improvements on the Property, whether now in existence or subsequently erected, against loss by floods to the extent required by the Secretary. All insurance shall be carried with companies approved by Lender, The insurance policies and any renewals shall be held by Lender and shall include loss payable clauses in favor of, and in a form acceptable to, Lender.

- 8. Fees. Lender may collect fees and charges authorized by the Secretary.
- 9. Grounds for Acceleration of Dobt.
- (a) Default. Lender may, except as limited by regulations issued by the Secretary in the case of payment/defaults, require immediate payment in full of all sums secured by this Security Instrument if:
 - (0 Borrower defaults/by falling to pay in full any monthly payment required by this Security instrument prior to or on the due date of the next monthly payment, or

- (ii) Borrower defaults by failing, for a period of thirty days, to perform any other obligations contained in this Security Instrument.
- (b) Sale Without Credit Approval. Lender shall, if permitted by applicable law and with the prior approval of the Secretary, require immediate payment in full of all the sums secured by this Security Instrument if:
 - (I) All or part of the Property is otherwise transferred (other than by devise or descent) by the Borrower, and
 - (ii) The Property is not occupied by the purchaser or grantee as his or her primary residence, or the purchaser or grantee does so accordance with the requirements of the Secretary.
- (c): No Walver. If circumstances occur that would permit Lender to require immediate payments in full, but Lender does not require such payments, Lender does not walve its rights with respect to subsequent events.
- (d) Regulations of HÚD Secretary. In many circumstances regulations issued by the Secretary will limit Lender's enights in the case of payment defaults to require immediate payment in full and foreclose if not paid. This Security, instrument does not authorize acceleration or foreclosure if not permitted by regulations of the Secretary.
- 10. Reinstatement. Borrower has a right to be reinstated if Lender has required immediate payment, in full-because of Borrower's fallure to: pay an amount due under the Note or this Security instrument. - 12. Successors and Assigns Bound; Joint and Several Liability; Go-Signers. The covenants and agreements of this Security instrument! shall bind and benefit the successors and assigns of transprayed and Borrower, subject to the provisions of paragraph 9.b.
