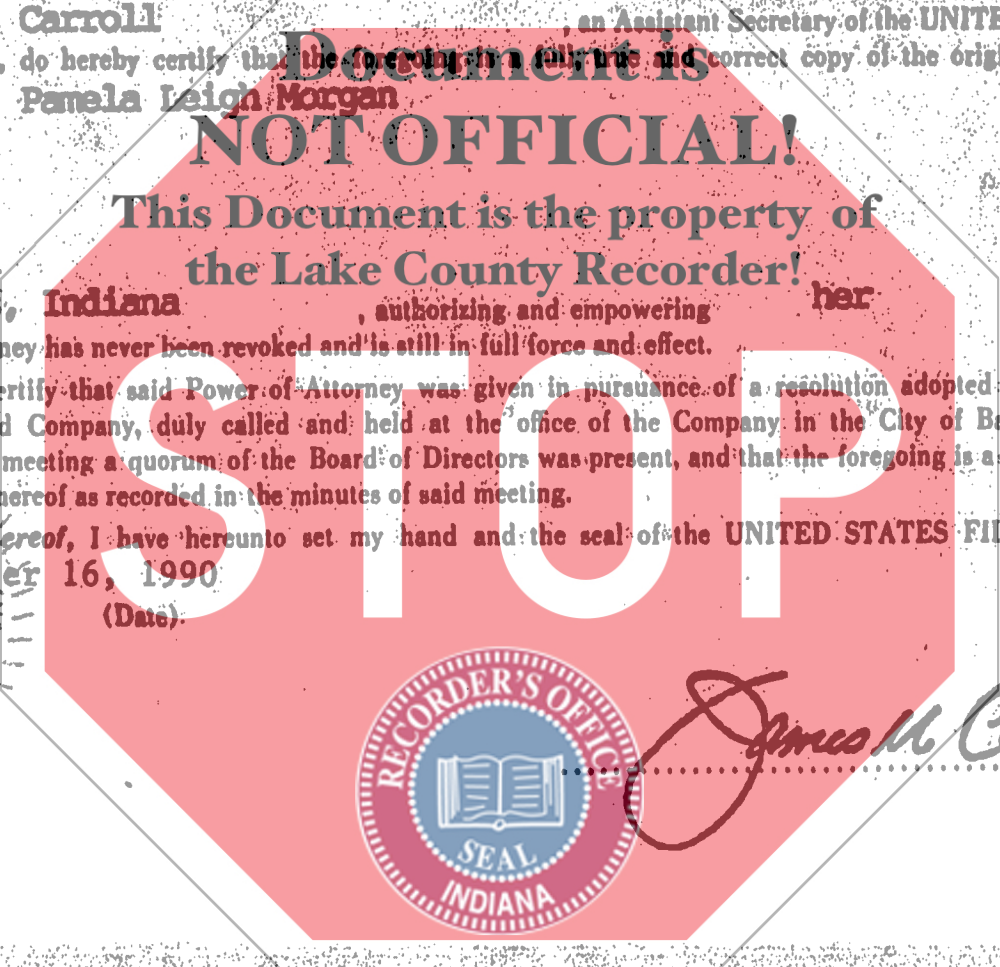
COPY OF RESOLUTION
