

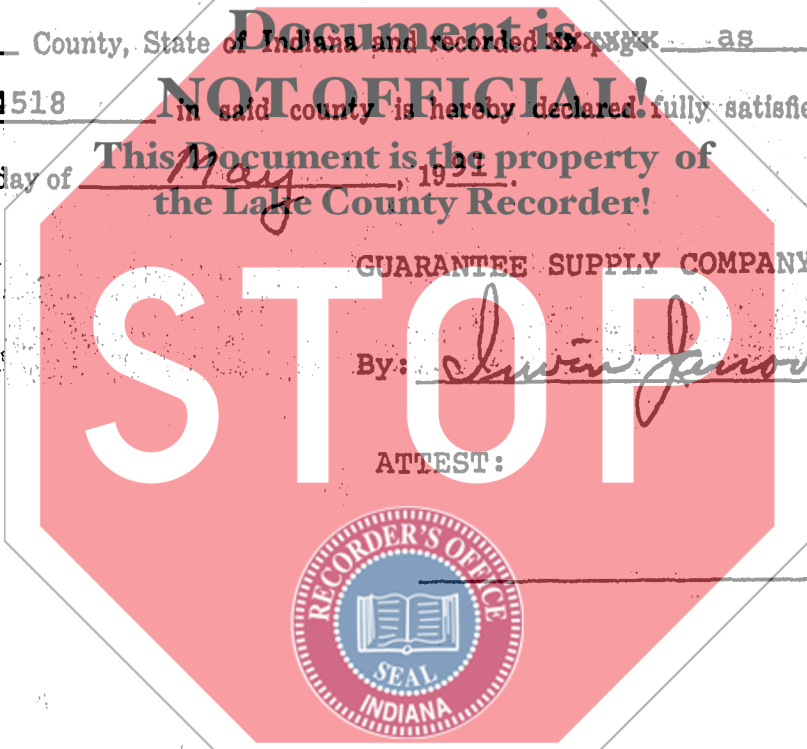

Part of the South Half of the Northeast Quarter of Section 17, Township 35 North, Range 8 West of the Second Principal Meridian in Lake County, Indiana, more particularly described as follows:

Commencing at the Northeast corner of said Section 17; thence South 00 degrees 04 minutes 02 seconds West 2,343.28 feet along the East line of said Section 17 to the Southeast corner of the South Half of the Northeast Quarter of said Section 17; thence North 89 degrees 46 minutes 13 seconds West 600.00 feet along the South line of the South Half of the Northeast Quarter of said Section 17; thence North 00 degrees 13 minutes 47 seconds East 134.63 feet to a curve having a radius of 223.80 feet, the radius point of which bears North 89 degrees 46 minutes 13 seconds West; thence Northerly along said curve 222.94 feet to a point which bears North 31 degrees 00 minutes 00 seconds East from said radius point; thence North 39 degrees 00 minutes 00 seconds West 250.00 feet to a curve having a radius of 321.27 feet, the radius point of which bears South 51 degrees 00 minutes 00 seconds West; thence Westerly along said curve 311.41 feet to a point which bears North 04 degrees 32 minutes 14 seconds West from said radius point, said point lies on a curve having a radius of 41.10 feet, the radius point of which bears North 04 degrees 32 minutes 14 seconds West; thence Westerly along said curve 38.63 feet to a point which bears South 49 degrees 18 minutes 37 seconds West from said radius point, said point lies on a curve having a radius of 110.00 feet, the radius point of which bears South 49 degrees 18 minutes 37 seconds West; thence Westerly and Southerly along said curve 333.61 feet to the Point of Beginning which bears South 55 degrees 33 minutes 00 seconds West from said radius point; thence continuing along said curve Easterly 224.32 feet to a point which bears South 61 degrees 23 minutes 57 seconds East from said radius point, said point lies on a curve having a radius of 40.30 feet, the radius point of which bears South 61 degrees 23 minutes 57 seconds East; thence Northeasterly along said curve 40.44 feet to a point which bears North 02 degrees 27 minutes 30 seconds West from said radius point, said point lies on a curve having a radius of 231.27 feet, the radius point of which bears South 03 degrees 27 minutes 30 seconds East; thence Southeasterly along said curve 219.84 feet to a point which bears North 51 degrees 00 minutes 00 seconds East from said radius point; thence South 39 degrees 00 minutes 00 seconds East 250.00 feet to a curve having a radius of 235.60 feet, the radius point of which bears South 31 degrees 00 minutes 00 seconds West; thence Southerly along said curve 161.31 feet to a point which bears South 89 degrees 46 minutes 13 seconds East from said radius point; thence South 00 degrees 13 minutes 47 seconds West 84.63 feet to a point 90.00 feet (measured perpendicular) North of the South line of the South Half of the Northeast Quarter of said Section 17; thence North 89 degrees 46 minutes 13 seconds West parallel with and 90.00 feet North of the said South line 847.83 feet to a point which bears South 21 degrees 00 minutes 00 seconds West 240.96 feet from a point which lies South 28 degrees 30 minutes 00 seconds West 289.87 feet from the point of beginning; thence North 21 degrees 00 minutes 00 seconds East 240.96 feet to said point which lies South 28 degrees 30 minutes 00 seconds West 289.87 feet from the point of beginning; thence North 28 degrees 30 minutes 00 seconds East 289.87 feet to the point of beginning, containing 7.243 acres, more or less.
