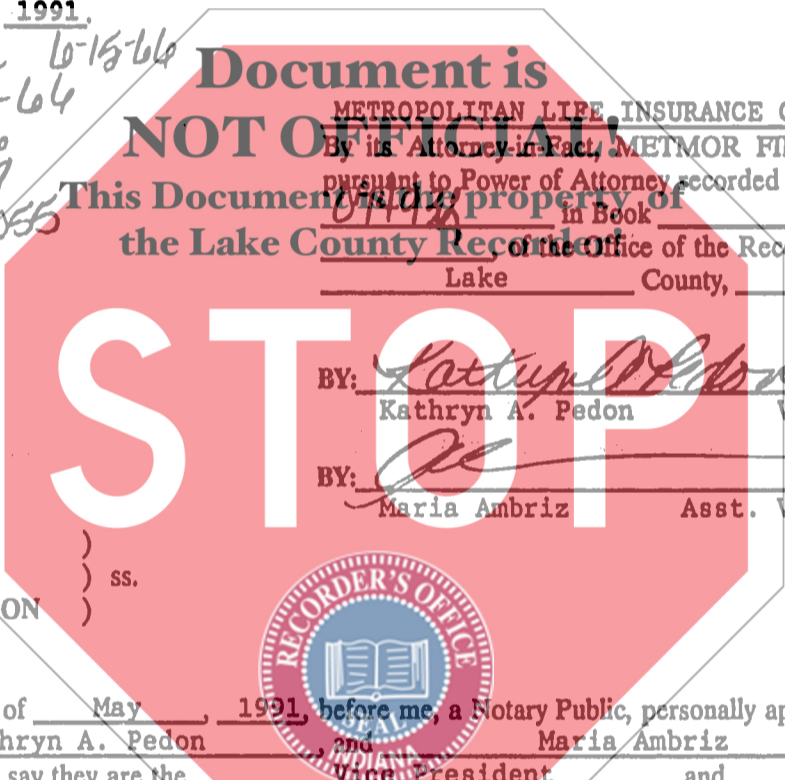
MORTGAGE RELEASE, SATISFACTION, AND DISCHARGE
