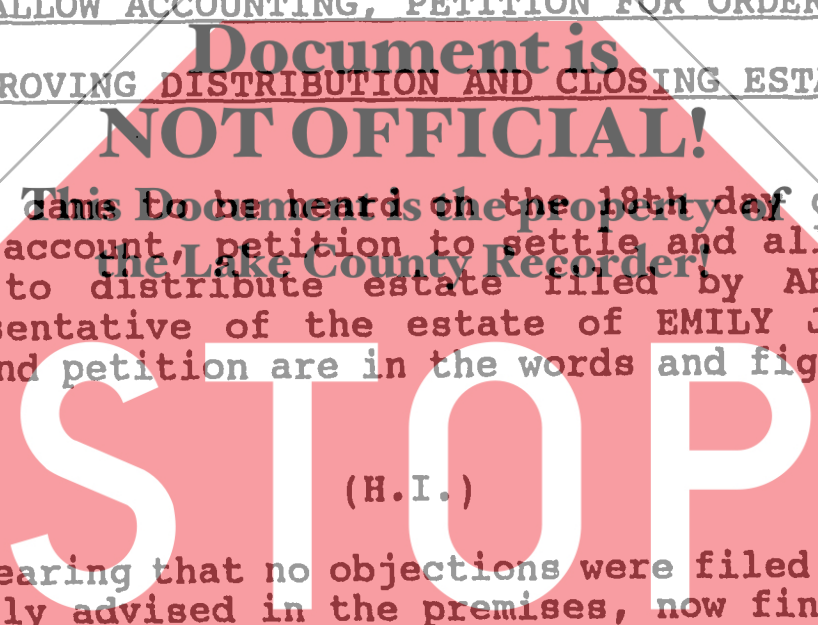

This cause was heard on the 18th day of April, 1991, upon the final account, petition to settle and allow account and for authority to distribute estate filed by ARTHUR JANA, as personal representative of the estate of EMILY JANA, deceased, which account and petition are in the words and figures following, to-wit:

And it appearing that no objections were filed thereto and the Court being fully advised in the premises, now finds that:

1. Due notices of the filing of said account and petition and of the hearing on the same were given to all persons interested in said estate, and the same are now properly before the Court for final action thereon.
2. That EMILY JANA died testate, a resident of the County of Lake, State of Indiana, on the 2nd day of August, 1990, and her Last Will and Testament was duly admitted to probate before this Court on the 19th day of September, 1990, and this Court appointed said ARTHUR JANA as personal representative of the Last Will and Testament of the decedent, and said personal representative was issued Letters Testamentary on the 19th day of September, 1990, and since that date he has continued to serve in such capacity.
3. That the matters and things stated in said account and petition are true and that said personal representative has accounted for all of the assets in this estate coming into his hands.
4. More than five (5) months have elapsed since the date of the first published notice to legatees, devisees, and creditors of said decedent; all claims filed against said estate have been paid

and discharged; neither said decedent nor his personal representative were employers of labor within the meaning of that term as used in the Indiana Employment Security Act; all estate taxes, inheritance taxes and gross income taxes, if any, assessed in said estate have been paid.

5. The following persons are the sole legatees and devisees under the decedent's Last Will and Testament: ARTHUR JANA and ROGER JANA, and that said distribution should be made to the above-named parties as set forth above).

6. That the decedent owned a certain piece of real estate located at 621 Farragut Street, Crown Point, in the County of Lake, State of Indiana, more particularly described as follows:

and that the decedent devised said real estate in Article VIII of her Last Will and Testament to ARTHUR JANA and ROGER JANA.

1. Said Final Report and Account of said personal representative is hereby in all things approved, settled and confirmed.

2. That the distribution of the balance of the property remaining in said personal representative's hands for distribution should be made pursuant to the distribution set forth in the final accounting as prescribed under the Last Will and Testament of said decedent and is hereby in all things approved.

3. That pursuant to the decedent's Last Will and Testament the following described real estate, to-wit:

Addition to the City of Crown Point, Indiana


is hereby vested to ARTHUR JANA and ROGER JANA pursuant to the provisions of the decedent's Last Will and Testament.

And that said personal representative is hereby directed to procure and record in the office of the Recorder of Lake County, being the county in which said real estate is located, a certified copy of this Final Decree.

4. Said personal representative is hereby directed to distribute the balance of the assets available for final distribution pursuant to the provisions of the decedent's Last Will and Testament.

5. Said personal representative is hereby directed to file his Supplemental Report showing that he has complied with the terms of this order and that said personal representative has in all things carried out the provisions of this final decree.
