This power of attorney shall be effective only on the 5/21/91 day of May, 1991.

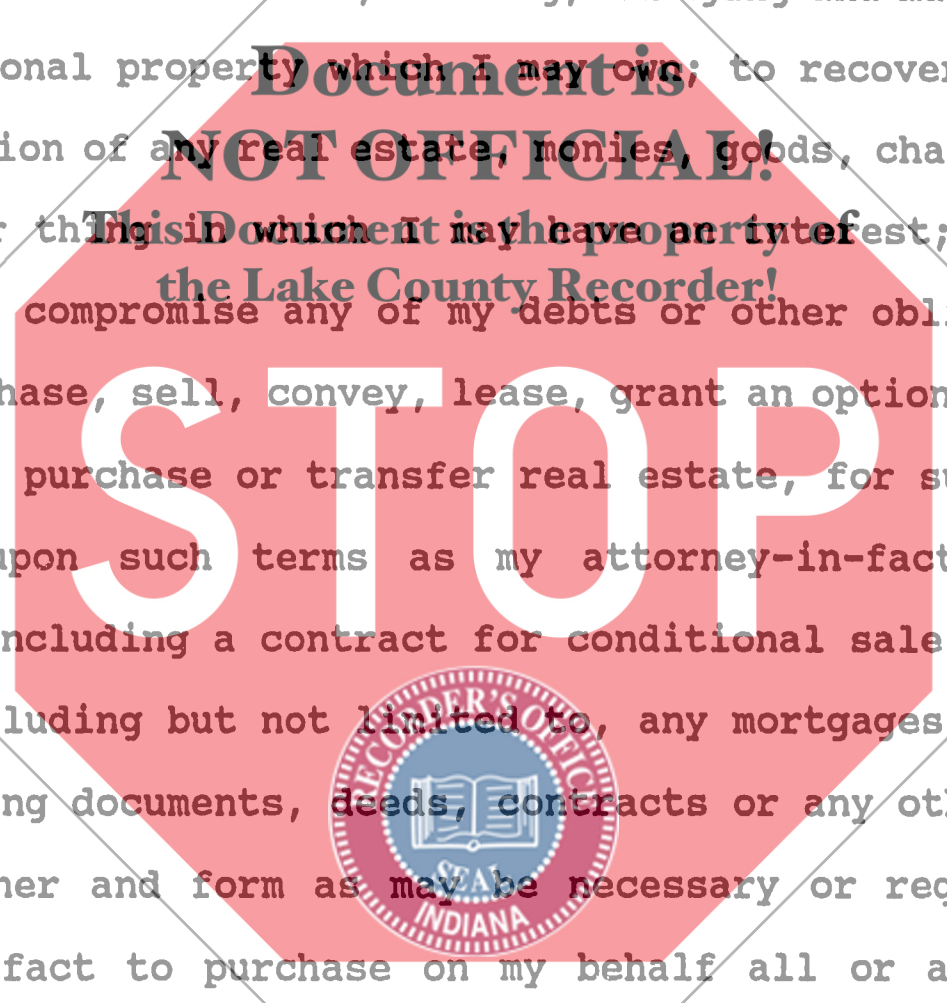
