The Grantee herein accepts this conveyance subject to the following:

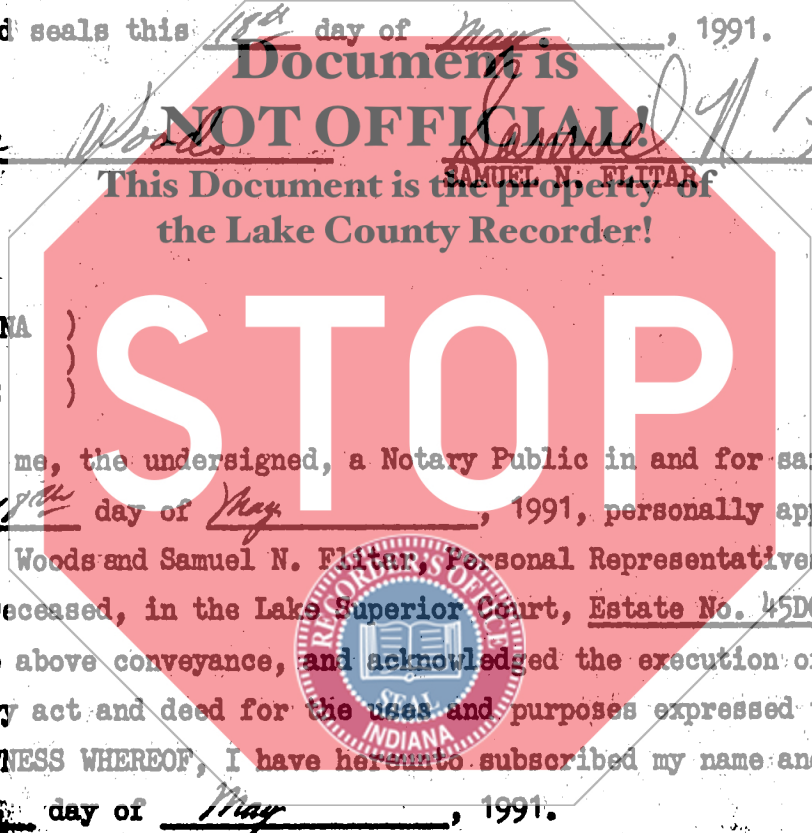
- 1. Taxes for 1990 payable in November, 1991, and thereafter.
