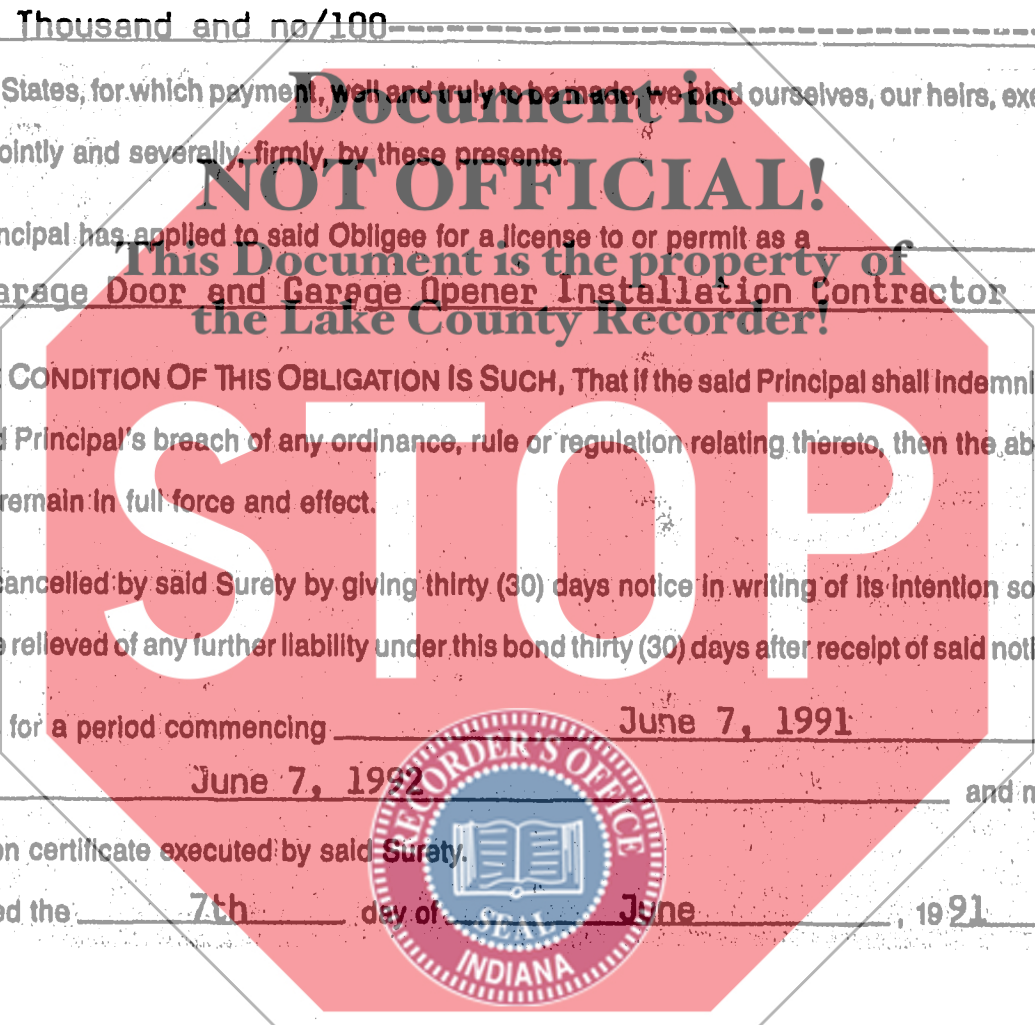
The term of this bond is for a period commencing June 7, 1991 and terminating June 7, 1992 and may be continued from year to year by continuation certificate executed by said Surety.

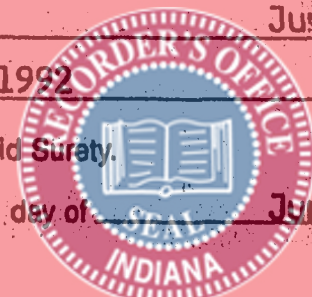

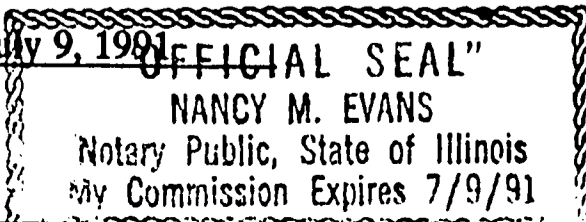

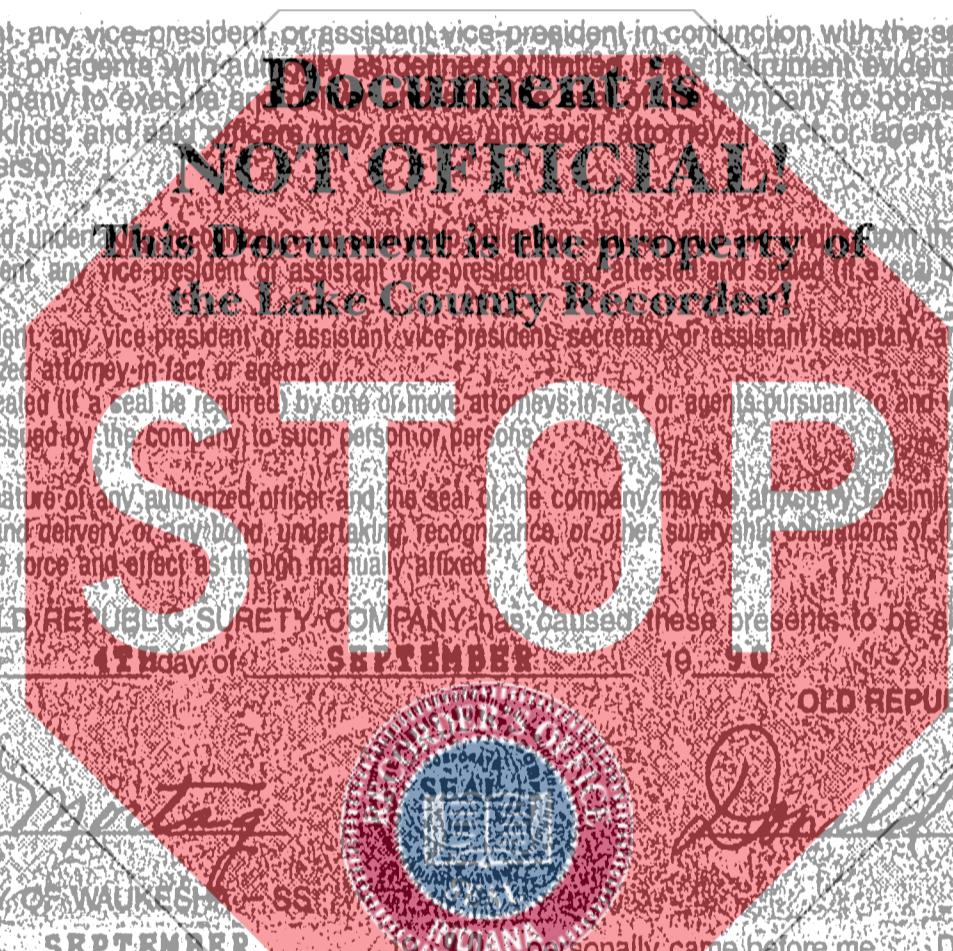
