- 2. No Liens. The Mortgagor shall not permit any lien of mechanics or materialmen to attach to and remain on the Mortgaged Premises or any part thereof for more than 45 days after receiving notice thereof from the Mortgagee.
- Repair of Mortgaged Premises; insurance. The Mortgager shall keep the Mortgaged Premises in good repair and shall not commit waste thereon. All sums so advanced and paid by the Mortgagee shall at the option of Mortgagee be immediately due and payable or shall become a part of the indebtedness secured hereby and shall bear interest from the date or dates of payment at the rate of eight per centum (8%) per annum. Such sums may include, but are not limited to, insurance premiums, taxes, assessments and liens which may be or become prior and senior to this mortgage as a lien on the Mortgaged Premises, or any part thereof, and all costs, expenses and attorney's fees incurred by the Mortgagee in respect of any and all legal or equitable proceedings which relate to this mortgage or to the Mortgageed Premises.
- Default by Mortgagor; Remedies of Mortgagee. Upon default by the Mortgagor in any payment to Mortgagee provided for herein or in the Agreement, or if Mortgagor has committed fraud, or made a material misrepresentation in connection with the account secured hereby pure Mortgagor acts, or fails to act, in a manner that adversely affects Mortgagor's collateral or any right of Mortgagor in the collateral, then and in the collateral or any right of Mortgagor in the collateral. such event, the entire indebtedness secured hereby shall become immediately due and payable at the option of the Mongagee, without notice and this montgage may be foreclosed accordingly.
